  - Shares from women, including "women in the military, single mothers and women of diverse backgrounds" for the 'AA for the Woman'.
  - o Stories from AA members who are gay, lesbian, bisexual, transgendered or gender nonconforming, especially regarding being a "newcomer" and "sponsorship" for the 'AA and the Gay/Lesbian Alcoholic'.
  - Recovery experience from members with mental health issues, AND from those who sponsor such members to develop literature for the alcoholic with mental health issues.
- Unity Day update from the Alt. Delegate Jane. Need details on how the various groups/members will participate. Thanks to our District for our commitment for participation and \$200 financial contribution.
- Two motions concerning Area tax records were tabled to research more information before returning to the Finance Committee for revision & resubmission to the ACM:
  - o Maintaining Tax Filing Records obtain advice from financial advisor/accountant on exactly what records should be retained and for how long. There's already a line item in the annual budget for tax preparation for \$350, which can be used as payment for these services.
  - o Annual Tax Filing ask financial advisor if an independent accountant should be preparing the annual tax report or if the Area Treasurer is acceptable.
- Still need increased contributions to the Area please ask your group for additional donations. The June financial report showed year-to-date contributions at \$17,600 and last year's contributions were \$21,000 after 6 months (so, \$42K annually, which was still below previous years and the current targeted annual expenses).
