District 21 Minutes of the Meeting December 3, 2015 Hamburger Factory, Poway, CA

Present: Brian, Jill, Line, Terry, Donna, Simon and Diana

Our DCM, Brian, called the meeting to order and began with the Serenity Prayer. Line read the GSR preamble.

There were no birthdays this month.

Minutes to the November district meeting were approved as submitted.

Simon gave the November treasurer's report: beginning balance \$882.46, contributions received \$63.60, expenses \$750.00, ending balance \$196.26. We discussed the expense for the rental of the venue for the January Area Assembly. We will be reimbursed by the Area for \$500 for the assembly. Food will be approximately \$1,000, most of which will be recovered by donations at the assembly itself. We expect a "real" outgo for the assembly to be around \$250. There are two other districts hosting with us. They can be asked for monetary contributions, though we don't have any commitment from them at this time. We discussed going to our groups for additional contributions. We discussed that we might not be financially able to send the DCM to PRAASA this year. We talked about the ramifications of that (there are two other district members who will be attending, so we will have representation) and how important that expense was; also, if it could be met over time next year, rather than with one reimbursement. The treasurer's report was accepted as submitted.

Registrar's report: Donna now has the listing of district meetings that Brian had prepared, and will work on maybe visiting (or getting others to visit!) meetings that don't have GSR's. She listed a couple of meetings she is hoping to attend in the coming months.

DCM Report

- Brian did not attend the Area Committee meeting this month. Diana reported that there were two motions brought to the ACM: one for non-budgeted expense reimbursement for the ASL committee who sent letters out to contributors advising that checks that would have been received during a two week period in January, 2015 were missing, and that if anyone had contributed during this time and didn't have a "cancelled" check, they should stop payment and reissue. This motion passed the ACM. The second motion was for a change in the structure and guidelines to change wording about who contributes to the Area from "groups, individuals and districts" to "members and all entities comprised of AA members according to our Seventh Tradition". After some discussion, this motion was voted to go to the Assembly in January, 2016 with a recommendation from the ACM to take same back to the groups. No action is required from us at this time. We will see the motion and act on it in January at the Assembly.

We will start asking for volunteer sign ups now, and reaffirm them in January closer to the event. Final planning will be at our January 7th district meeting.
