<u>Old Business</u> – We discussed how the distribution of the Doctor's Opinion pamphlet was going, and to contact me if any additional copies are needed. Jill took copies for distribution at the next CPC meeting.

Visiting unrepresented meetings – We continued to review our district's meeting list to try to identify meetings to visit to offer our assistance and support. If we plan to visit a meeting, then email the committee so we can attend the meeting in pairs (or more). There are some duplicate meetings on the list to be removed or merged that I will be handling.

<u>New Business</u> – Harry, our treasurer will be moving, so we need to find a replacement. We have some possibilities and will review them at next month's meeting.

Visit from Delegate – Brian arranged to have Dean visit our next meeting to provide any additional insights from the GSC.

Item for future discussion: Holding a 'Group Inventory' workshop in the area.

We had a discussion about how to find out how the entities we contribute to are doing; where we can get the information, and, at the district level, can we create a budget so we know what we need and so the new treasurer knows what's going on.

Round Table Sharing – The GSRs provided descriptions about the happenings at their meetings. They are motivated to carry the message and be responsible so that the hand of AA will always be there to the suffering alcoholic.

Chairperson's Report: Roxane R. (absent—emailed report)

As a school teacher my life runs on a calendar. In my experience, the month of May is the most difficult in a teacher's life. The culmination of a year is one thing but it is really the year end festivities and events that make it so overwhelming. Even veteran teachers find the students almost unbearable, with no sustainable appealing qualities, and no hope that they ever will possess any. The spring fever that was disgustingly tolerable has dissolved into an apathetic attitude that could be compared to a man sentenced to life imprisonment. Indeed, you wonder how the students can endure when they have nothing to give or receive in the way of learning. Despite these deplorable conditions, I arrive each day with my heart full of gratitude that I can be a contributing member of society and repay my drunken debts as a living testimony to the program of Alcoholics Anonymous.

As your Chair I am particularly indebted to Concept 5, "Right of Appeal," for teaching me more than I ever wanted to know about chairing an assembly and allowing me to grow in patience and tolerance. Concept 5 has special significance in the lives of AA members everywhere. Co-founder, Bill Wilson, had much to say about minority opinion in Alcoholics Anonymous. He called trusted servants, "a small but truly qualified minority." Because Concept 3, "Right of Decision," gives the group service representative the right to do for the group what the group cannot or should not do for themselves, this naturally culminates with Concept 5. By allowing the minority opinion the last word on decisions from the groups, we have a chance to rethink a situation. How I lamented when an issue in our assembly took a turn I did not support. I would ask for minority opinion and then hold my breath until someone came forward. Listening to a heartfelt appeal after a vote and then asking the group if minority opinion had changed anyone's vote was either exasperating or exhilarating. Whichever outcome prevails, I feel confident in the power of the 12 Concepts to keep us humble and open to new ways of thinking.

To my delight, I spent much of April in contact with various trusted servants in Area 8. I am fortunate to have a panel of committee chairs and members who put AA first and have endeared me to them for life. H & I is a wonderfully hardworking group of alcoholics who do so much with so little. Policy committee is headed by a brilliant member who possesses much insight and experience about Area 8. The Information and Technology Committee who oversees our website among other jobs, never disappoints. The Agenda Committee should be given credit for the much acclaimed success we have had with this year's assemblies and area committee meetings. Most recently I have been in contact with the North County Young Peoples Committee Events Chair, Riley, who is looking for support to keep a dwindling group from falling apart. I learned here that when someone reaches out, we want the hand of AA, always to be there. For that, I am responsible.

I will be regrettably absent from the May Area Committee meeting and Gonzalo, our Alternate Chair will chair the meeting. I am obligated by contract to be present at our annual Open House at school which falls on May 21. I am looking forward to the Post-Conference Assembly where our Delegate will take us through the agenda items and what happened at the Conference. To someone like me, that is what AA is all about.
