# Chairperson's Report: Roxane R.

Having arrived home two days ago from a two week adventure beginning at the AA International Convention in Atlanta, Georgia, I am happy to share that AA is in very good hands. According to the 7<sup>th</sup> Concept, the Conference Charter is not a legal document, unlike the Charter and Bylaws of the General Service Board. But it does rely upon tradition to run AA. This sounds conflicting but I am finding many conflicting things in AA General Service. We are bound to hear and see things in AA that don't match our own experiences. Ultimately the Trustees are protected by us and through us so the members are now and forever will be the caretakers of the Conference Charter. Essentially, we rule AA.

If I had to choose one story to take away from the convention it is the story of Sammy who shared his experience, strength and hope with us on a panel which our Regional Trustee, Joel, facilitated, called: Pacific Region-Meet Your Neighbors. There was a large group of San Diego attendees at this panel and I think many of us thought we'd hear Joel speak at the conference. We were laughing and joking together beforehand and giving snide looks towards Joe C. who chose not to sit with our bevy. This was not our first panel, in fact for me it was my 6th panel, and we knew there would be the usual 5 minutes of disclaimers. When we finally settled down we heard first from a man who got sober in Hawaii where he had landed with the Marine Corps at the end of his drinking and quite possibly the end of his career. Next we heard from a long-timer and Past Delegate who came from Idaho and had a poignant story about complacency and resentment in sobriety. She was hilarious.

When Sammy came to the podium my preconceived ideas kicked in and as I noted his bow tie and perfectly groomed hair I smiled to think I had figured out this effeminate man's struggle to be accepted and how it drove him to drink to cover up his unease at not belonging. There. Story over. How quickly our minds take over when we have the luxury of sitting with over 30 years of sobriety, seemingly immune to this deadly disease.

I watched Joel who never took his eyes off Sammy and I even thought, "He's enraptured by this boy's history." Sammy told of the father who did not accept him and how leaving his family was the best thing he could do for himself because it forced him to reckon with his sexuality, his drug addiction and his alcoholism. It was a similar story to many of us who have sobered up early—how we can pack a lifetime into about 6 years of hardcore drinking. So many of us never make it out alive. And here is Sammy—another success story.

By now he is explaining his relapses and the only really sober periods he had in AA was when he was involved in General Service. I loved this part. He tells us about his relationship with Joel and how Joel came along when he most needed the guidance and helpful push to keep committing to service work even when others were uncomfortable with his change. This is the part where we all perked up. We know about change but it was the way Sammy said it—his change. I realized it was a noun, not a verb. I was quickly rethinking his previous comments and berating myself for not listening, truly listening to this precious boy who it turns out, was born a girl. He was a she and now she was becoming a man and suddenly I had no cliché ending for this remarkable story. His articulate, brave, and endearing story will stay with me for a long time to come. I know I heard him and because I heard him I will share the love.

I hope your summer is shaping up into one of those where you get to hang out with family and friends, read a good book or two, work in your garden, build something big and take a pleasure trip to learn something new about yourself. I am honored to be your chair on this panel.

## **Motions: Maintaining Tax Filing Records**

The motion is to add the text Sec.V.G.7 Proposed text 7. File yearly tax documents in a timely manner, and provide copies to the Finance Committee.

Questions or comments

Do you think we can do this without going to the group? It's good to be open and straight forth ever now and then.

Is there one place where everything is being kept? No, this came to light that everything was a different place. This is why this was created. We believe in the structure and guidelines, the chair has most of the responsibility but not the documents.

Are the records electronic? We may want to move to a digital means. We received an email conformation in electronic form that the filing has been done.

Who has been keeping the records at this time? We believe the treasurer has the last 7 years. The responsibility will fall on the committee and not the treasurer. There is a concern of the information getting lost.

Have we ever been audited? No, not that we are aware of. We need to have the last 7 years on hold. All of our financial stuff is at question here. This is something that we need to address. How all the financial records are keep?

In the past our process was done differently. The thought is to do differently and have in a central location. We know there are records out there and we want to bring them together in one place and protect the area.

I was a previous Treasurer from years past. At the end of my term, I turned my paperwork into Archives. Some of the records may be with Archives. We would want to keep and maintain records for 7 years and destroy the records at the proper time. Setting up a proper maintenance program to have it done in according with government regulations. Having the Archives is a good idea.

I don't think that a committee should have to maintain something they have no special knowledge of. We have an Archivist who is part of the Archives committee. This person is interviewed and trained in this area. We have a fire proof room where stuff is kept. If this goes to the Assembly, this is mostly the discussion that you will here. Officers are listed as responsibilities of certain duties. We will not have an idea that we will always have a chair with knowledge of non-profit organizations or status. We have a problem with rotation. The person that is handing off or accepting the documents, there name is not on the table. There is an investment that is not there if we have an Archivist do it.

What do other areas do? Not sure because most are 501.c3. Area 5 for example, has a Tax committee. We will need to seek out the help of a CPA or CEO of a finance firm that could help us. I know that we seek the reference of other areas. We are different. We are a charitable organization. Anyone who contributes money to us does not write it off on our expenses. We are exempt as an organization from paying taxes but anyone who contributes to us does not.

We are the steering committee and not a board like Area 93 or 5. Therefore we do not have judiciary responsibility. This is why this is important. So the next panel will have the correct status to the financial responsibility of the area and how its maintained.

It should be a officer level person who is handling this. It should be the treasurer who passes this on to the next treasurer as part of the Finance committee.

Should we set these aside for the time being? This would be up the originator. Most felt like the motions should be set into two. There are two different actions even though are talks are hand in hand with each other.

We will put this on aside.

A floor motion was made by Kevin to refer back both motions back to Finance committee. We would like to send clear message that we would like to Treasurer or the Finance Chair be responsible for this. A single person has to do this. We need clarification about the first motion to proceed.

It doesn't say anything in the second motion that the Treasurer is responsible. We need to make sure who is responsible to keep and maintain the electronic records.

It does make since that we have one body taking care of this. It makes sense that the person doing the filing should be keeping the records. We also has a password protected area on the website. We could have a backup copy on the server. If the documents got lost or transition period we need to find the information, we would have it.

We would want checks and balances. If the Treasurer and Finance chair both has the authority, this almost seems better.

Are the records electronic? The documents are not electronic. We can scan them. We received a electronic confirmation that the filing has been done.

Taking the idea of taking this back to the Finance committee is best at this time. We are only taking a stab in the dark as to how we need to proceed. This is about maintaining our non-profit status. Keeping this together in the eyes of the state and government. We as a practice, we do not require special skills and knowledge of the chair or the treasure or the finance committee. The finance committees doesn't have special finance knowledge. What happens is a car pulls up and exchange of a bunch of boxes, and good luck. That is it. There is no idea what's in them. We have been in this room and the treasure announces that I got a letter from the state that we haven't filled for a three years. We need to know what the rest are. How do we build and practice the appropriate guidelines. This body will get a report that taxes have been filed properly. We should be filing a sales tax with the state. We do not owe the state but I don't think that it's being done.

We have an account that we do not pay for a few years. Is he someone that we would want to come and talk to us? We have a line item set up to pay someone. We can take a guess but this is very critical to the person or committee who stands in the duty of an officer. We do not want some officer getting in trouble for not know the correct or proper procedures.

Our guideline has verbiage that applied to a 501.c3. At one time, the error was made. We found out later that we are a 501.c4. and just replacing the 3 with a 4 and the difference is critical.

We are try to build a guideline for future trusted servants and we are not following the law. Where do we thing we are at? Should we ask the body about following the law? We should follow the law. We don't need a guideline to follow the law. What are going do in the short term?

It's about who is going to be responsible? We have heard that it "we" maintain it. It is the concern of the finance committee to come into the position and not know what to do. They will have guideline to go by for doing the position. We know for personal experiences is to have good records and keep them in a safe place. We want to bring it to the group. The first step is safe location.

Could we put the hard copy in the storage locker? No there is not enough room.

We need an itemized list of what we need to retain and what are the filings that we need to do? We are only gather information. What is that we need retain? What do we need to do to maintain our status non-profit status?

Why can't we put them on the website? If we are transparent we are following the law. No one needs to vote on that as a body. It has names and can't post. It's a legal issue.

There is a motion but it's not ready yet. Should the person who signs the tax returns be the same person who stores all the records or a different person?

The Treasurer recommends that we get together with the person that handles our accounting and come back with questions and information to present back to the committee.

Would GSO have any information on this topic? We are autonomous when it comes to this type of subject.

I run my own business, all we need to do is to go to the board of equalization. They will tell us everything we need to do. They are there to help us. All we need to do is ask for help.

Let's send back to the Finance. Thank you for all of your help. We are holding them.
