## July 2018 Delegate's Report

Concept 7 says that the Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the trustees are thereby fully empowered to manage and conduct all the world affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for it's final effectiveness.

Having received dozens of emails regarding the changing of the date of the General Service Conference, I have, in my capacity as delegate to Area 08, voted "no" to the change. I want to believe that the Trustees and General Service Office staff have conducted themselves as recognized by Concept 7, but ultimately it has left many without a voice or choice. I will keep you posted on the outcome.

Area 64, Tennessee has submitted a proposal to the Panel 69 Conference regarding the agenda item selection process and to provide delegates an enhanced role in the vetting and selection of agenda items. I have included copies of the proposal at the end of this report.

The GSRs I've met along the way have been inquisitive and engaged in the Conference process. The website does have slide presentations available in English only for those who are interested in sharing the Conference results.

Have you made your \$7.40 contribution to GSO yet? Remember that last year's \$7.27 challenge was the single greatest factor in increasing our revenue for 2017.

As you know, I will be attending the Regional Forum in San Jose in September. I hope that many of your districts will fund the DCM and others to attend. I look forward to moderating the topic, "Safety in AA."
