# Delegate's Report: Tom M.

In an effort to reduce the amount of information disseminated at the meetings we are keeping the reports to less than a page. Area Contributions listings has arrived but before it is distributed there will be some changes by GSO. Area 8 contributions have dropped from 30% to 25%. GSO cost of service per listed group is \$137 In 2011 the average

contribution per group was \$97. This \$40 shortfall requires that literature sales pick up the slack. Email this info to your groups. Form number SMF176, (available on the aa.org website,) lists how GSO uses our 7<sup>th</sup> tradition contributions. When your group sends money to GSO this is what happens to an individual's money. In addition there are some listings of new groups that have started and are now listed with GSO. We are notified when a group is added which is where the costs begin. Remind your group of our primary purpose.

There is a trustee vacancy and an election coming up. This position rotates after the GS Conference in 2013. We will have nominees at November Assembly. It is a Class B (Alcoholic) position. Tom read a list of all the requirements for this position and it will be sent out to all DCMs, Committee Chairs, Past Delegates and the Intergroups. Another trustee vacancy is for a Class A Trustee, non-alcoholic. Deadlines are coming up. See Box 459 for more info.

Pacific Regional Forum will be held in Fairbanks, Alaska in Alaska. Registration is free and a hotel is only \$89/night. GSO staff will be there. This experience is different than PRASSA and more intimate with GSO staff. Workshops are smaller and it brings you into much closer contact with GSO.

Grapevine *Quote of the Day* is up and running. It is easy to register for this to be emailed to you each day. Sometime this month a new Grapevine book, "Young and Sober" will be available. Six new e-Books are also appearing this month.

## **Area Inventory Ad hoc Committee**

A meeting for this committee will be scheduled to take place before the end of June. The links to these surveys are available at <a href="www.area8aa.org">www.area8aa.org</a>. The deadline has been extended to June 30, 2012. I have sent reminder emails to all on the Area Roster. Links to the survey tool were provided through which we are collecting responses.

Cooperation with the Elderly Community (Gary) PowerPoint presentation borrowed from Area 5 presented.

Discussion: There are many "groups" that support the elderly. Hawaii has done 40 pages of work on their CEC committee. Have you thought of becoming a sub-committee of the CPC committee? You would not be reaching out to local clubhouses that do not have professionals. Outreach at the committee level is difficult. Specializing in one area usually helps this. Look at how effective you can be specializing in one section of the population. Generating interest in CEC may help our CPC Committee. CEC has their place—being able to go to professionals in the geriatric community—and CEC wants to add to the current standing committees. If Area Committee does not move forward with the creation of the CEC committee do we have people in other standing committees who can take up the banner for the elderly? PI is offering racks of information to be placed in various locations throughout San Diego County. These do reflect the population that exists in this area. Our primary purpose is to carry the message...are we doing this? It seems that the committee structure already exists within CPC, PI and H & I...it is already difficult to keep these committees filled.

#### Policy Committee's Review of Recommendations by Ad hoc on Guidelines Review

The Area's Policy Committee will complete its review of the Ad hoc Guidelines Review Committee's suggestions. The Policy Committee will present a version of the Structure & Guidelines that includes all the grammatical and clarifying (non-substantive) changes at the July ACM.

**Cooperation with the Professional Community Committee** Jerry C., Past Delegate, was appointed to the Cooperation with the Professional Community Committee (CPC). Jerry served as Chair to that committee in one of his many general service positions. I know Jerry will make a great contribution to the committee's work.

#### **Chair Visits/Discussions**

Due to the need to replace the Translation Chair, I want to take this opportunity to learn more about the translation needs of our Spanish-speaking Districts and Intergroups. Other Area Officers, such as our Alternate Delegate and Alternate Chair, regularly visit the Spanish-speaking districts and Intergroups. I am hopeful I will hear from each of them on how we can improve our two-way communication with translation of area business documents from English to Spanish as well as Spanish to English.

- Agenda: Karen: We have a new member in the Agenda committee, Linda Z. GSR for the I.B. Up meeting. Jane presented the June Area committee meeting agenda. The committee reviewed, amended, and approved the agenda. We will begin working on the September Big Day Agenda at our next meeting in July.

This seems outside the spirit of warranties of concept XII and so the area may want to consider modifying this section. Three warranties were read in response to this. Warranty 6 (look this up) No one member...no action to be taken in anger, haste or...personally punitive. In talking to the Area Alt. Delegate is seems that one person can force another out of a position. Discussion on this followed.

SDIAIC: Chris: Juvenile Hall is requesting more meetings. George Bailey Prison asking for a new mtg. opening for the "fifth yard". We have openings on many panels. Are you willing to give as little as one hour a month?

Translation: Mike, Alt. Area Chair reported for Ruben: Ruben resigned. He lost 2 translators and translating approx. 35 pages each month, an hour per page. Minutes arriving with only a 10 day lead before due date. Continuing need for translators. Need documents sent to translation by specified date.

Archivist: Joe: No report

CEC *Ad Hoc* (Cooperation with the Elderly Community): Gary: We have gathered resources submitted by various members and asked P.I. Comm. and CPC For feedbacks and information. We will continue to discuss this among committee members. Will be connecting with other areas that have CEC Committees. This ad hoc comm. looks toward July to be able to report back. Statistic: 10,000 seniors celebrated their 60<sup>th</sup> birthday today and this will continue for the next 19 years.

# **AREA COMMITTEE BUSINESS**

Progress on Ad Hoc Considerations:

Item 13. Quorum: Should standing committee chairs be included in the quorum count? The AA Service Manual (p.S4) considers committee chairs to be area officers. Guidelines may need to be clarified.

Item 14. Scope of Area Committee: Guidelines state that Area Committee "...recommends the format and agenda for the Area Assembly." Some Area 8 chairs have consulted the committee on the agenda while others have not. Is there a need for cross-referencing in Section V?

Item 23. Replacing Standing Committee Chair: Section III, E, includes a provision for replacement "upon recommendation of the responsible area officer. Should the Area consider modifying this section?

"When groups send money to the districts they want to make sure the district's needs are filled before sending the money—keep the money local until you are done with it and then let it move on. Cash flow in AA is affected and since we have expenses at different times of the year, the districts are sometimes affected. Review this annually. "

Finance committee response: This suggestion was sent via email. Our charter is to enforce the structure and guidelines we have no opinion on this.

Discussion: Clarify—the motion is to amend the current policy from quarterly distributions to annual distributions. If a committee or district can come up with a legitimate reason for holding on to money, this removes all of the natural boundaries of prudence in how we spend our contributions. If a district has a good budget then holding on to money serves no purpose. The 7<sup>th</sup> tradition is a spiritual concept. There is divine guidance when it comes to money in AA. A motion was made to send this to the finance committee. It was seconded and approved. Finance said they did not know what that would do.
