Conference Report in August. AA.org website now has a button to click on each day's "Daily Reflections." Grapevine will soon be offering a "Quote of the Day". You can sign up for email delivery of the "Quote of the Day." You do not have to be a subscriber. There is also from AAWS a new "self-support" initiative. The trustees are looking ahead on trying to become self-supporting through member contributions. The print world is giving way to the digital world. This will eventually affect Big Book sales. Our literature sales have always helped to support the groups. With vision we must look to the day when literature sales will not be able to do this. We need more financial participation from the groups. We are about 50% short of supporting group services. Member contributions must increase if we are to keep AA afloat.

Trustees have the custodial responsibility for our fellowship. The have had to put out fires since the recession hit four years ago and the tanking of *Grapevine*. A new vision is to leave behind those crises and look ahead and manage the fellowship the way it was structured.

On Saturday we will be serving ice cream at the end of the Assembly so there is a good reason to stay the whole day. Tom passed out buttons from the Conference that say, "Service-Whoo-Hoo!"

iPhone app for the Big Book and 12 X 12 is being reworked to improve the app. The Android app will not be available until they work out the bugs in the iPhone app.

#### Alternate Delegate's Report: Dean B.

Besides serving ice cream, three districts will co-host a continental breakfast before the Area Assembly. GSR Orientation begins at 8 am. The "So Cal Convention" originates outside this area but Dean is the liaison. This convention has a time slot and a room set aside for a service presentation. Archives. On the 1<sup>st</sup> and 3<sup>rd</sup> Mon we have a step study meeting of the Concepts. On the 4<sup>th</sup> Mon. we have the GSRs reports. We have turned in our PRASSA report to the groups through the GSRS. We are working on a Sponsorship Committee. Corrections Committee meets every Tues. PA committee to traffic school every Monday.

District 19: Jennifer: Things are going well. We have a GSR orientation which helps get new GSRs started.

District 20: Margo: Not present.

District 21: John: No report.

District 22: Tom: 12 GSRs present at last meeting. We are working on the structure and guidelines. We have a new alt. treasurer and a new registrar. We updated Central Service Office meeting schedules.

District 23: Mark: One new GSR. 8 in attendance. We are planning and preparing for the report back assembly. We are co-hosting the Labor Day Picnic with District 2.

### **STANDING COMMITTEE REPORTS**

Accessibilities: Alan: Sign language fund (gold can) currently funds 5 meeting each week at a cost of \$600-650 a month.

Coming into April the fund was down to \$150. Any groups interested in adding to this fund, contact chair.

Accessibilities is asking interested groups to add new brochure or special needs to their literature collection.

Agenda: Vince: (Secretary) Chair has health issues. We could us 1 or 2 more committee members. Agendas are fun.

Archives: Wes: We need group histories. Forms are on the website in English and Spanish. We can visit groups and put on a display or make a presentation. ROOTS event has speakers confirmed. We could use 4 members, no experience necessary.

CPC: Jeremy: Really short on help. Need GSRs or other people who can volunteer for this committee. Project are on hold until there is more support.

Finance: Paul: 2012 Approved budget. In building the 2013 budget we have budget requests that work out to about 49K. Treasurer made some cuts down to \$42K but we have to do it further down to \$40. We cannot exceed projected contributions. We are now tracking about \$33K for actual. Finance pleas for receipts keeps us below the 25% mark for GSO. This is an illusion. We are not actually that healthy. We bring money in faster than we generate receipts often coming up short. Visit your groups and speak about what the area does. Encourage groups to consider keeping a percentage of contributions at the local level. We have to generate a budget based on revenues. If our revenues remain low we cannot compensate officers at the level we need them to operate.

Grapevine/LaViña: Suzanne: Planning for Unity Day's continental breakfast. Also working on a skit for Unity Day.

Aagrapevine.org We are working a possible writer's workshop for August and also planning to attend YPAAs "Service Palooza" in July. Committee formalizing visitation process to districts to get more grapevine reps.

Information Technologies: Steve: Please take a look at the new website because it is looking real good. Our webmaster got a job. Last meeting had 7 in attendance including Alt. Delegate, Dean. We discussed new website issues and area computers. Archiving minutes was mentioned as well as the assignment of tasks to new members and old.

Literature: Ray: We are in the process of reviewing videos for newcomers. We are reviewing "Sure Beats Sitting in a Cell" We want a picture of what the videos are appropriate for in the event you want to use one.

NCAIC: Rich: Orientation meeting, 3<sup>rd</sup> Friday, in July. Oceanside Alano Club; Panels are working well and there are always openings for alternates and new members. We need a policy and guidelines person and a Spanish liaison. Our budget is \$13K and most of it is literature. We only carry one correctional facility, the Vista Jail—the rest are treatment facilities.

Newsletter: Chris: Meeting this Saturday during lunch at the Area Assembly. Latest newsletter published to the area 8 website. PDF version sent to email addresses on the committee. Acting editor is unable to make copies of newsletter without support. Former chair of committee will help out in this area to get affordable copies printed. Committee seeks new editor and registrar.

Policy: Paul: Nothing to report.

SDIAIC: Chris: We take meeting into hospitals and other institutions. Corrections Chair reported that meetings are back at Calipatia and we are working with Spanish liaison regarding central detention. We take 31 meetings per week into correctional institutions. We take 66 meetings a week into Hospital settings. We are also working with our Spanish liaisons to bring meetings into the Miramar Brig. Treatment chair is moving and a new one will be appointed at next meeting. Contributions are down. We simple adjust our literature purchases. Unity day presentation will be to recruit panel members. We have openings on many panels. Are you willing to give as little as one hour a month?

Translation: Mike, Alt. Area Chair reported for Ruben: Ruben resigned. He lost 2 translators and translating approx. 35 pages each month, an hour per page. Minutes arriving with only a 10 day lead before due date. Continuing need for translators. Need documents sent to translation by specified date.

Archivist: Joe: No report

CEC *Ad Hoc* (Cooperation with the Elderly Community): Gary: We have gathered resources submitted by various members and asked P.I. Comm. and CPC For feedbacks and information. We will continue to discuss this among committee members. Will be connecting with other areas that have CEC Committees. This ad hoc comm. looks toward July to be able to report back. Statistic: 10,000 seniors celebrated their 60<sup>th</sup> birthday today and this will continue for the next 19 years.

# **AREA COMMITTEE BUSINESS**

## **Registrar**

Monty: Continue to promote the election of a registrar for your district and that person could be the lead on this trek. Set that meeting up to be visited in 2 months. Once again, promote their attendance at the District Meeting.

## **DISCUSSION FROM ROUND TABLES:**

Do GSRs understand their commitment including the standing committees? It's the DCMs job to inform the GSRs of the extent of their commitment. The blind pick does not work. They go to one and then they stop going when it does not match their expectations. It does open the door however. What is the value of the committees? So liciting the GSRs isn't the only way to fill a committee. The system could use an update.

Blind pick: Most people felt blind pick was not working avowing that it was too much too soon. Thrown into the "fire" is the current way to introduce new GSRs to committee work and perhaps a delayed period would allow the GSR to absorb

more about how we do business at the assembly. Those new to service needs more orientation. Orientation should take place at the district level. Volunteers could be from a larger pool rather than just working with the GSRs.

Announcements about area needs to fulfill positions of area service could be made. Eventually we could allow the volunteers the vote after a period of time.

Blind pick: Encourage GSRs to attend as a guest first before they are assigned. They might get turned off to all committees if they end up not "fitting" the assignment. Filling a vacant chair position is a policy decision. Why can't a volunteer fill that position. The committee can assign people to fill vacancies. Assigning special skilled workers could be done by making a special request. Volunteers could also be solicited from the groups. The newsletter could run an ad to fill a special position.

Large groups of comm. members provide perspective but some committees don't need a lot of members. Try to make the committee membership attractive and fun. Half of the DCMs were part of standing committees and the other half were not. If it is not fun—look at the calendars before picking a committee to serve on. Stay in touch with your committee members in order to find the right person for the job. Being on a committee enlarges your circle of friends.
