<u>Delegate's Report: Tom M.</u> (Written Report Submitted)

We are able to change the date because the Coordinating Council graciously gave up their time at Torry Pines ChTom began his report with a quote from the Grapevine regarding how Service adds to sobriety in a positive way.

<u>Alcoholics Anonymous World Services</u>- One of AAs most high profile examples of the spirit of rotation took place at the General Service Office on July 15 when eleven staff members assigned to be contact points for the various committees and regions rotated to new assignments. The purpose of the rotation is to make sure the staff members on assignment have experience in all the assignments and that no individual becomes vital to the existence of AA. The General Service Conference Coordinator asks that all areas submit area newsletters to help share AA service experience throughout the

US and Canada. I've notified the committee chair (Raphael) of the request. Final conference reports should be available in late August or early September and I will distribute them at the September Area Assembly.

The suggested contribution to cover delegate expenses to the General Service Conference increased to \$1600.00 in 2013 but the Conference Coordinator asks that each area consider contributing more than the minimum since actual costs per delegate are closer to \$5.400.00 each.

<u>Grapevine, Inc. -</u> One on One is a new book released by the Grapevine in print and digital format. It is an anthology of Grapevine articles dealing with sponsorship with stories on choosing a sponsor and acting as a sponsor. It is currently available from <u>www.aagrapevine.org</u> for \$10.99 and for download from Amazon for \$9.99.

Grapevine circulation continues to decline and is now about 79,000 but La Viña circulation has increased again to 9,531. The Grapevine is approximately \$97,000 ahead of budget forecast for 2013 but this is mostly due to the time of the year and this level of profit probably won't be sustained for the entire year. La Viña is running about \$2,500 below a budgeted loss of \$44,606.00.

The Grapevine board will present a report sometime in 2013 on the feasibility of producing one book in ASL format. Grapevine management will visit the offices of La Vigne, the French Canadian newsletter that is similar to Grapevine, for the purpose of gathering information on the distribution model used in French speaking Canada. Management will also be developing recommendations on reducing La Viña costs as a way to reduce transfers from the General Fund of the General Service Board. Grapevine management has submitted suggested copy for an opt-in letter that could possibly be sent by AAWS to General Service Representatives and Group Contacts to obtain permission to use their contact information in the AAWS data base. You may remember this was an issue we discussed after the General Service Conference in May.

Grapevine Quote of the Day circulation is now 19,456 subscribers.

<u>District Visits-</u> Dean and I continue to make visits to districts to highlight some of the actions of the General Service Conference and to remind GSRs that summaries of the conference actions have been posted in English and Spanish on the area website, www.area8aa.org.

Alternate Delegate's Report: Dean B.

I know it's unusual but I'll be brief tonight. Arturo and I got together and finalized the Unity Program budget for 2014. Some of that carries over from 2012 and we ended up being \$200 in the positive. Thanks to all the hosting groups. They'll receive reimbursement checks in about a month. Tom and I are visiting groups to discuss the upcoming Assembly topics, including the 2014 Budget.

<u> Area 8 Chair: Jane G.</u>

Guidelines vs. Bylaws

The question of whether Area 08's Structure & Guidelines are bylaws or guidelines leaves me to believe we must take them for the word "guideline" in the title.

The IRS Form 1024-Application for Recognition of Exemption, in the records held by the Area Treasurer, indicates a two-part Statement of Policy filed as SDIA's bylaws in June, 1980. The Operating Principles are listed as one part of the bylaws and the other part are A.A.'s Twelve Traditions. A hard copy of the Form 1024 is held in SDIA's records; however, the page that holds the Operating Principles is missing.

The SDIA documents mention adopting the same Operating Principles as those of The San Diego Coordinating Council and The San Diego-Imperial Area Institutional Committee. In order to secure a copy of the Operating Principles missing from the filing, I contacted both organizations for their copy and neither has a copy that existed in or prior to 1980. I also asked Area 08's Archivist to search the Area Archives for a copy of the Operating Principles and/or its Structure & Guidelines as of 1980 or prior. The Archivist was not able to find those records. I also went to several Past Delegates requesting the same. No one has supplied these copies. The only answer I can supply is that there is no evidence that Area 08's Structure & Guidelines are bylaws. In fact, the evidence supports the Operating Principles and The Twelve Traditions are its bylaws.

One other open question is whether the Operating Principles, as they currently appear in Area 08's Structure & Guidelines, ever included the words "plus an ample reserve." Until we can recover a copy of the original Operating Principles, we may never know. There is a section in IRS Form 1024 requiring an explanation on how assets will be distributed on dissolution, and the following statement appears:

There is no plan to distribute assets. We generate only enough funds to operate on a budget basis for one year and attempt to accumulate a "prudent reserve" for that purpose. This sole asset is a commercial bank account.

I understand from one of my conversations with a Past Delegate is that Area 08's Structure & Guidelines were only a single page in 1980 and remained that size until the adoption of the Standing Committees. This search led me to, once again, review the Major Motions at the back of Area 08's Structure & Guidelines. I did note a Major Motion dated 1-11-76 regarding Policy Statement Review. The note is to disband the committee to review the Policy Statement because there was no need at present.

As a side note, it appears the Area has lost some records in the past. It is noted in the Major Motions the Major Motion records from 12/1955 to 1/1964 (8 years) are missing.

Proposed clarifying statement to the title page of San Diego-Imperial Area's Structure & Guidelines:

Contributions to the San Diego-Imperial Area Assembly of the General Service Conference of Alcoholics Anonymous, a 501(c)(4), are not tax deductible.

The wording in Section XI is not DIRECTLY stating contributions to SDIA are tax deductible. However, the concern that the wording may lead to the assumption the contributions are tax deductible is the CPA's reason for making the suggestion to insert and display a clarifying statement on the title page of the S&Gs. Many, including the CPA and me, have interpreted the wording to say the contributor may take a tax deduction on monies given to SDIA.

I know I took the same view you just took until I read it several times. Here's what Section XI holds:

- B. Notwithstanding any other provision of this Structure and Guidelines, the organization shall not carry on any other activities not permitted to be carried on:
- 1. by an organization exempt from Federal income tax under section 501(c)(4) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), or
- 2. by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

The statement is actually talking about what activities the organization will NOT perform. It mentions 170(c)(2), which pertains to 501(c)3 organizations. It is believed this entire section was inserted in error. There was a time when the Area thought and acted as if it was a 501(c)(3). It developed that thought because Area 08 evolved from the Coordinating Council (San Diego Intergroup), which is a 501(c)(3). In fact, there were several years where the Area filed tax returns as a 501(c)(3). The story goes, Section XI of the guidelines was inserted as a copy of what was originally held in the San Diego Coordinating Council's guidelines. The existence of the phrase concerning section 170(c)(2) of the Internal Revenue Code of 1954 is a good indication this was the case. This was and remains to be a mistake. The guidelines have never been corrected. I am all for the correction of the guidelines. This may be a project the Policy Committee would like to undertake. However, in the meantime, adding a simple clarification of the 501(c)(4) status, which includes the fact the IRS does not allow tax deductions for contributions made to it, does serve to clarify the S&Gs. It does not in any way CHANGE the S&Gs. It does quickly answer a question of concern that may be held by an IRS agent who would call up the S&Gs for a quick read. Correcting the quick read is the main concern of the CPA.

I am all for the amendment of Section XI. However, the suggestion of inserting a clarifying statement of fact onto the title page quickly remedies any unintentional misunderstanding. As we know, an actual change of the guidelines will take many months.

Area Archivist - A discussion was held on requesting the current Area Archivist to remain in the position for the additional two years provided for in the guidelines.

Discussion: We are not a 501C3. The difference is that contributions are tax deductible for the contributors. Most of our funds come from the groups, not individuals. Our contributions are accessible by IRS. Suggesting that we put on the page that contributions page add clarification words.

If we change the wording it would require a motion.

We are just asking for your direction, as a steering committee, as a disclaimer. It would not require a motion. Tonight we could just allow policy to put the line in as a clarification.

This is the quick fix and a more formal process would follow I think that is a fine idea.

DCMS we have many motions making their way through our ACM and we need you to make sure these motions are explained and presented to your groups.

Area Archivist: Is there any discussion about having the Area Archivist continue in his position for an additional two years. If the trusted servant would agree to continue, we can take a sense of the meeting. It would take a performance evaluation for this to happen. We might want to focus on finding an alternate. The process requires a committee and other specific ... It is alright to announce an outreach for resumes as early as one year before the archivist's term is ended.

It spoke to the long tradition of service between the San Diego Young Peoples committees and Area 8.

The pie chart 37% is going to administration in carrying the message. The groups are voting with the power of the purse and we are not going to be able to fund its officers and its committees.

AREA COMMITTEE BUSINESS

Motion Presented: Section XII, E clarification.

Current Text: (XII) E. Each committee of the Area Assembly, or any other component of the Area Assembly, including the Area Assembly itself, may adopt any guideline, bylaw, rule-of-order, or standing rule it deems necessary. As long as it does not contradict Area 8's Structure and Guidelines or any principle of Alcoholics Anonymous.

Proposed Text: (XII) E. Although these Structure and Guidelines cannot be set aside or overruled while conducting the business of Area 8, each committee of the Area Assembly, or any other component of the Area Assembly, including the Area Assembly itself, may adopt any guideline, bylaw, rule-of-order, or standing rule it deems necessary. As long as it does not contradict Area 8's Structure and Guidelines or any principle of Alcoholics Anonymous.

Discussion opened to be continued from last month: No discussion ensued.

Called the question.

All in favor of ending the discussion: 9

All opposed: 5

Someone please read the motion to get us back in the spirit.

Discussion:

Amendment proposed. At the end of the 3rd line, add

If the question was called and voted and in favor of ending the discussion. The vote is whether or not it is being recommended by the Area Committee to bring to Area Assembly.

All in favor: 3 All opposed: 17

It will go to assembly without recommendation. Minority does not wish to speak.

Clarification: Does this mean that if it goes without recommendation then we can change the guidelines any time we want to without going to the groups.

You might be reading more into this.

We can only vote with the people who are here.

I did not recommend this because it opens the door to people interpreting the guidelines to suit themselves. I can look at the 3 things stated in the background and read 3 different ways. When the people in the Assembly vote, we do what they tell us, whether we recommend or not.

We should move on to the next item.

MOTION:

Proposed amendment to the Area Assembly S & G

Motion to Establish a CEC Committee (Cooperation with the Elder Community)

(See text) Add a subsection 14 ...to establish

The finance Committee has since reviewed this. They suggested this be turned into an ad hock committee for a 2 year period. The presenter of the motion accepted this suggestion. A friendly amendment was added to this effect. There are some concerns about budget considerations. If there is a challenge for this then all other committees might consider tightening their budgets to allow for the addition to the budget. The elder community has very different needs.

Discussion:

If it was an ad hoc committee it would not be included in the S & G. It would not need to be a motion. You could This motion creates a standing committee.

It was recommended and it has been accepted to be willing to create an ad hoc.

Would you like to modify this language for us tonight or are you going to come back.

I'm going to ask the chair to appoint an ad hoc committee.

We do have some past experience for this. It could be an appointed committee, like the computer needs committee. I think there is real value to take an idea like this to the area Assembly. It gets the whole assembly to buy into it. When we tried to establish the gold can. It was not agreed to let cash be handled by a committee. My past experience is that it should go through the whole area assembly process.

I don't understand how we are talking about ad hoc committee. What happened?

The process means it goes to policy and finance. Finance suggested that this start as an ad hoc. The amendment to the S & G is not necessary.

If we brought this to the assembly, then we could get committee members to join.

What about the money?

This is more about the 12 step work we perform as an area. This is an excellent opportunity to show how the 12 step work gets generated.

What is the difference?

They don't require money.

I am confused. If I understand the process. Has the motion been withdrawn? Yes.

There are two versions of this motion. One with no money and one with money.

In the past the chairperson has appointed ad committees for something that something that needed to be explored. We sometimes converted these to standing committees. Or not. The cart is before the horse.

There is no motion. The motion was withdrawn. We need to move on.

MOTION: Proposed amendment to the area assembly S & G

Create an Area WEB SERVANT. There is no current text.

Proposed Text: 11. The Area Web Servant is an appointed member of the Information Technologies Standing committee.

a. The Area Web Servant position will be a non-traditional rotating position for a period of four (4) years.

The Information Technologies Committee will review the Web Servant's performance every two years and make a recommendation to the Area Committee on continued tenure. At the end of the four (4) year term, renewal for a final term of two (2) years is permitted following such a review. The Web Servant may not hold a concurrent position in the Area Assembly nor Intergroup.

b. Appointment of the Web Servant will be made by the Area Committee by the following process:

- (1) The Information Technologies Committee will advertise the position per its guidelines.
- (2) A screening Committee composed of the Information Technologies Committee Chair, Alternate Delegate, and an Area Committee Member appointed by the Area Committee Chair.
- (3) The screening Committee will make a recommendation to the Area Committee where final selections will be made by a simple majority of an Area Committee vote.
- c. It is suggested the Web Servant have at least five (5) years sobriety and have service experience at the Area or Intergroup level.
- d. The Area Web Servant is a voting member of the Information Technologies Committee and the Area Assembly.

We have a web master and we have to place this information into the S & Gs. (See Chair report.)

(This verbiage has been extracted from the archivist position with changes.)

Discussion:

I'd like to see the line that reads "The web servant's performance will be reviewed every two years..." I'd like to see the Area Assembly approve this.

Under the notes section it is not in sequence. Everything is number 1.

That can be amended.

All of this came from the Area Archivist position in the S & Gs.

Would this position upset the balance of voting members?

This person would be counted as a GSR. It is only two people.

What he is trying to say about the count is that it is categorized and listed at the assembly and committee differently.

The Area Archivist is counted under liaison. How would we count the Area Web Servant?

We won't be changing the balance other than we would need 2 more GSRs.

Why would it be important to have the web master be a voting member of the assembly?

I helped copy this specifically to reduce confusion. The importance is that the have a right to participate mainly because they put in many hours and many decisions will affect his servant status.

I agree that he should have a right to vote.

I would support this motion and I appreciate the effort to the importance of this position. It is a leadership role. The area puts together a selection committee for this position. We might be taking away authority from the area chair. Friendly amendment under Item A, the first sentence remains. Strike the next sentence completely and rewrite it to

state: (Motion is written above with amendment.)

The friendly amendment has been accepted.

Any further discussion?

The question was called.

Vote to close the discussion: 33 in favor and none opposed.

We will vote to send the motion (as amended) to the GSRs: 32 in favor and none opposed. The motion passes.

New Business: We need a sense of the meeting.

Phil: Thursday Night Mira Mesa Men's Group would like to propose the addition of a table of Contents be added to the pamphlet, "Frequently Asked Questions About AA" (Formerly "44 Questions") This pamphlet is an excellent general service information tool. **Discussion:**

I think this item should get moved forward.

I think the entire area needs to see this.

Do you want this presented at the Area Assembly? No

There is a process recommended to the conference that the groups take it to the district, then to the area committee and then to the area assemble and then the delegate rights the letter. With all this history then they might get it set in the agenda. Even if we wanted to object this, if it has gone through all the proper steps it can't be rejected.

You are right. The maker of this motion can send it directly to the conference but to go through the channels then this is one way we can get something into the agenda items.

It's a great proposal.

I want to say that I am in favor of this and it is a 30 page pamphlet and not all of it is relevant to all people seeking membership in AA.

I don't think it is a matter of having greater viability if it has gone through the service structure.

We may not have that kind of weight. We are only 50 people in here.
