## Delegate's Report: Tom M.

**Box 459:** The summer issue of Box 459 is available for download at <a href="www.aa.org">www.aa.org</a>. The issue is devoted to the 2013 General Service Conference and contains an excellent article describing the origin and timeline for the Conference Inventory scheduled from 2013 through 2016. Box 459 can be a useful tool for GSRs when reporting to their groups. It can be printed from the website and circulated through a meeting if the GSR does not already receive it in the mail. A subscription form for electronic delivery can be found at the aa.org website directly under the "Past Issues" menu. I emailed Box 459 and the newsletter, AAWS Highlights, to DCMs, committee chairpersons and officers and will forward the Archives Newsletter Markings when the Spanish Translation is available. However, you can visit aa.org to download and print copies of all the newsletters now.

Opening for Staff Member at the General Service Office—An opening on the paid staff at the General Service Office exists for an AA member with strong service background and good people skills. The position includes managing a staff assignment such as the Public Information, Literature, or other assignment and includes answering inquiries from the fellowship, managing information related to the assignment and arranging events. Qualifications include 6 years continuous sobriety, good communication and computer skills and the willingness to relocate to New York City. Deadline for application is August 1, 2013.

Opening for Class B Pacific Regional Trustee- Our current Regional Trustee Rod B. will rotate out of his position following the 2014 General Service Conference and the Areas of the Pacific Region can offer nominees for his replacement. Area 8 will conduct an election for our nominee at the November 16 area assembly. Qualifications include a suggested 10 years sobriety and a strong service record including General Service Conference experience but In Area 8 we allow all AA members, regardless of type of service, to be eligible for election as a Class B trustee. Please contact Jane or myself by mid-October if you are interested or know someone who is interested.

Opening for Non Trustee Director at AAWS- An opening for Non-Trustee Director at AAWS will exist when Joe D. rotates out of his position following the 2014 General Service Conference. One of the qualifications for this position is past service as a delegate to the General Service Conference so the pool of candidates in Area 8 is small but circulating this information through groups may be a way to passively inform the at large AA member of the existence of this position and provide an avenue for those interested in more information to ask questions of GSRs and DCMs. I've sent an email containing the announcement and the resume sheet to DCMs. The deadline for submitting an application and resume to the General Service Office is July 15 2013.

<u>District Visits-</u> During the summer months I'll be making visits to districts to encourage GSRs to make reports on the 2013 General Service Conference or to hear any reactions the groups had to conference actions. I have sent out a document to all DCMs and Committee Chairs that summarizes the conference actions on the specific items we discussed at our Pre-Conference Assembly. The full list of 2013 Conference Advisory Actions and Additional Committee Considerations is posted on the <a href="www.area8aa.org">www.area8aa.org</a> website for download and for use in reporting to groups.

<u>Grapevine-</u> The new audio portal landing page is now live at <a href="www.aagrapevine.org/audio-portal">www.aagrapevine.org/audio-portal</a>. The sample stories on the website can be downloaded to your phone, tablet, or laptop as mp3 files and played for GSRs at district meetings or at groups. If you are a DCM interested in adding a new dimension to a district meeting why not consider downloading one of the sample stories and playing it to inform GSRs on the Grapevine Audio Project.

A written announcement regarding the opening of the Area 08 Archivist position will be posted soon. The term for this 4-year position will begin January 1, 2014.

#### Section XI of Area 08's Structure & Guidelines

An oral report to be followed by a written report regarding a CPA's answers to the questions developed by the Ad hoc Committee to Review of Section XI was delivered. The main reasons for reviewing this section is that, in order to maintain its standing as a non-profit, the San Diego-Imperial Area (SDIA) is required to fulfill regulatory requirements, such as tax filings. In making those tax filings, the area officer uses his/her full name. Tax filings for non-profits, which also disclose the full name of any area officer(s) included in the filing are public and accessible on the internet.

The CPA who was asked to answer the committee's questions was recommended by three individuals who responded to the Chair's request to the Area Committee members for CPA referrals. All three individuals recommended the same CPA. The CPA provided his services pro bono to answer the committee's questions, file the federal e-post card (2012 tax filing), and agreed to file SDIA's 1099s for 2013 in January 2014. The CPA SDIA is a 501(c)4 and is not required to file a tax return because its fiscal (calendar) year contributions are less than \$50,000. Even in years when SDIA's contributions may exceed \$50,000, there may still be no need to file a tax return. The CPA will file the e-post card and create SDIA's 1099s on a pro bono basis in the future. More details about the CPA's recommendations will follow.

#### **Bylaws vs. Guidelines**

As a follow-up question, the Ad hoc Committee to Review Section XI was asked to review this question: ..."whether Area 08's Structure & Guidelines are, in fact, guidelines or are they bylaws" was presented at the Dec. 2012 Area Committee Meeting. This same question has been regularly submitted in the conduct of area business. The ad hoc on Section XI was asked to research this question and engaged in a search through the Area's records. To date, there is no evidence SDIA's Structure & Guidelines are bylaws. In fact, the June 1980 filing of IRS Form 1024, Application for Recognition of Exemption, indicates SDIA's bylaws are its Statement of Policy. The detail of the Form 1024 indicates the (bylaws) Statement of Policy has two parts: 1. The Operating Principles; and 2. The 12 Traditions of Alcoholics Anonymous.

The problem is the page that holds the copy of the Operating Principles is missing from the filing. The documents show the historical roots of SDIA being created from The San Diego Coordinating Council of Alcoholics Anonymous (Intergroup). Also shown is the creation of the San Diego-Imperial Area Institutional Committee (SDIAIC). All three entities: SDIA, Intergroup, and SDIAIC were known to have the same Operating Principles. Neither the Intergroup nor SDIAIC have any historical copy of the Operating Principles existing in 1980 or are thought to be those mentioned in the filing. We request help from any past trusted servant who may know where to find a copy of the Operating Principles.

The CPA recommends SDIA maintain a copy of Form 1024 readily available in its records in order to present it at any request made the IRS. He also said the IRS would not be interested in reviewing either our bylaws or our guidelines. I will check with the IT Committee to see if a records vault can be set up in order to electronically maintain such records so they are not lost in any rotation or other unanticipated condition.
