Motion to move Native American from a Liaison to a Committee: Jeff S.; Duncan-both he and Jeff have been discussing making the Native American Liaison into a Standing Committee of the Area-largest number of reservations in one area in the nation. Should be a committee of Natives and non-Natives//recommended to start as an ad hoc committee of the Area-response that this was started at the Local Forum//Remote Nations Area Committee//Recommended that this group meet regularly for a year as an ad hoc//next step is to take to policy.

Background: Reservation meeting are geographically and sometimes culturally remote, however a network of sober, dedicated, service minded people are available to reduce the remote nature, people willing to give their time to travel, start meetings provide service talks etc.

Area 8 established a Remote Nations Committee in the early 2000's. After a completion of that committee's major project, a pamphlet of Native American recovery stories, the committee disbanded, though a Native American liaison was established. The Liaison has never been a funded position and the Liaisons acted mostly alone. See links for motion details: Motion Background

District 2: Bill-Priority #1 this year is to endeavor to enhance the sobriety of some members by carrying the message of the 7th Tradition in terms of "being of service." In particular to encourage the groups to actively and financially support their GSR's efforts (e.g., events, assembly, standing committee meetings, even printed materials, etc.) and to invite the participation of the Alternate GSR; "as if" they were a co-GSR

instead of a fill-in. We hope this approach may open the door for some to participate in general service who currently are not and increase 7th Tradition effectiveness and of greater understanding. The District likewise is preparing to annually budget / contribute towards the GSR's travel and related expenses to events such as PRAASA, regional forums and neighboring District and Area events, when their groups cannot. A call to all Area 8 Districts and committees to consider a collaborative effort is sought. All members would be well served to learn of the standard that Area Officers, DCM's and Committee Chairs have approved budgets that fund nearly 100% of their Twelve Step efforts (travel and related expenses) and that groups who are financially able, be encouraged to do the same.

District 12: Joe; District 12 meets on the first Thursday of every month. This month we had 8 GRS in attendance. The topics were the upcoming Area Assembly, the districts upcoming events for 2019, ASL, Emotional Sobriety workshop, and a financial report and projections.

District 13: Ronnie; We lost one GSR due to money issues from the Women's Empowerment Workshop. The women's empowerment workshop had a budget of \$350, and the workshop went over budget by \$300. We gained another GSR from the Wed night women's group. My two GSR's entrusted to put on the Meeting Fundamentals Workshop did not fulfill their responsibilities and we are not able to put on the workshop.

District 14: Sandy; Our District held a holiday potluck. Not as many members could come, and there were but 6 of us. With no planning ahead of what to bring, we had beverages, 2 appetizers, a salad, a meat entree, a side dish and vegetable and a dessert. How does that perfect balance and variety happen? It's just magical. So it is with our Mental Health Issues in AA workshop. We have the leadership to fill every responsibility with ease and balance. I am so grateful for the amazing AA members who grace our District with their time and talent; their willingness to lead and serve. Our new tentative date for our Workshop is on

June 15 from 9-1. A seed is germinating in our District to form and support a bilingual women's meeting. I became aware of a woman who freshly out of treatment, in need of a sponsor, is being taken to the Spanish speaking meetings near her by her daughter. Her daughter described behavior in the meeting that was not conducive to recovery and when I asked her what geographic area her mother lived in, she said Ocean Beach. That's my District. There is much to investigate before it happens, but to meet this need is the desire of our District and it has the support of our GSR's.

District 15: Valentin; We had 6 new GSRs at our district meeting, totaling 20 GSRs, Committee chairs, CPC, PI, La Vina, IC and IT. We worked on a PRAASA Budget and was approved for \$515.00. We have started to visit our groups. Two of our groups contributed to the area.

District 16: David; Last met on Jan. 7th with 14 people in attendance. A presentation by Dana H. was provided regarding the inaugural North County New Year's Eve Bash. It was widely viewed as a success, with 385 registered guests that attended and very good post-event reviews. The expected turnout was much greater than expected and, as a consequence, a decision was made to order additional food "on the spot" to provide food for everyone. This decision carried a large expense that ran the event over budget by over \$3000. While a mistake was made, it was presented with humility and honesty and the organizers of the event have learned valuable lessons to take into the next year for planning. One AA member is currently carrying the burden for this decision on a credit card and District 16 decided to issue an additional \$1000 to help with this debt. The District decided to bring the issue to their groups to see if they would be willing to step up to help with an additional contribution.
