Additionally, to provide a professional perspective, to health care professionals who are familiar with A.A. were asked to review this pamphlet and found it to represent an accurate cross-section of alcoholics they have come into contact with in their professional capacity. This is a thick pamphlet with a lot of stories in it that we in the literature committee felt was done very well and will touch anyone who has any related mental issue and wants to stay sober. It is 41 pages and packed with great stories that relate directly to the issues. One final notes: If one can work on their sobriety their metal health will improve and one who can work on their mental health will improve their sobriety. The trick is to find the balance and this pamphlet will give insight into this journey.

#### **New Business:**

1. Motion-Operating Expenses (S&G) Paul K.; Financial impact to the area are unknown.

<u>Motion</u>: There is no current text. This motion is being brought forth to add the following text as: Section VI..I.1b. → In the section 1b will now become 1c.

The Area Committee is authorized to purchase "capital equipment" that has been lost, stolen, or is non-functional. Funding will come from the line item in the current year's budget for to the specific capital equipment. Any additional amounts required for the purchase will be pulled from the Reserve Account. The expenditure should not exceed 2/3 of the Reserve Account balance. A report on such expenditure shall be submitted to the next Area Assembly by the Area Treasurer or the Area Chair.

Capital equipment is:

- 1. Computers and Software
- 2. Copiers and Printers
- 3. Audio Visual Equipment and Accessories
- 4. Translation Equipment

**Background**: Costs for Major Capital Equipment items usually exceeds the limit of \$450 that the Area Committee can authorize for an unbudgeted expense request. The unavailability of Major Capital Equipment can interrupt the smooth functioning of the Area Committee. For example, area officers rely on computers to perform their duties. The need to wait until the next assembly to vote to replace this equipment could be very disruptive to the operation of the Area.

**Discussion**: Up to  $\frac{2}{3}$  of what?//  $\frac{2}{3}$  of the prudent reserve// Do we know a full inventory of what we have?// We have one in process// this motion is important for us to access funds from the reserve if needed// the problem seems to be that we are not property budgeting for the replacement of capital equipment.// this motion is not referring to what
