Treasurer's Report:

• Dave provided a roster of district meetings and their annual contributions. Current balance is \$5484.27. Discussion of contributions and funding initiatives by GSO (the \$3.60).

DCM Report

December ACM

- Attended by alt-DCM Terri. Jerry, our new Delegate, has been assigned to the Grapevine committee by GSO.

- Timeline for GSO conference discussed (preconference is March 28, conference is July 2-5.)

New Business

- Final duties assigned for January 11 Assembly. Districts 5, 4, 19, and 21 will host. Diana will need help unpacking breakfast food at church on Friday afternoon. Tom Q will bring 8 dozen doughnuts; Wigs will bring 'starter coffee' from Starbucks. Ice and water will be left to District 19. Six volunteers needed; we arrive 7:00 a.m.

- New DCM training February 15.

- District 21 monies, allocation, prudent reserve: We have a significant amount left over after meeting obligations and must decide the proper way to use these funds. Agreed: we don't need a large prudent reserve. Agreed: we will not re-apportion funds to pie chart if those monies were already portioned out by District 21 groups (example: if a group used their pie chart to send us 5% of their funds, we will not turn around and reapportion those funds to GSO, Area A, etc.) Proposal to identify area groups or committees that need a financial boost and help fund them (ex. ASL). Next month Dave E. will prepare pie chart of where our extra monies come from, and we will vote on a statistic (not a number) to determine how money flows.
- Committee assignments: The Blind Draw method was discussed and is generally not liked by GSRs. Matt suggested each GSR instead receive a list of committees by name, place, time, and short description so that GSRs can choose for themselves. General agreement.
