<u>Presentation of the Motion to Change the Duties of the Finance Committee - Final Vote September 12, 20202</u>

The table below shows that before the pandemic, there were over 1640 meetings listed in the directories of our local central offices. The following number is presented to give you an idea of the strength of the current ability to reach groups in matters about AA as a whole. Groups need a General Service Representative, commonly referred to as a GSR, to be informed on matters affecting AA as a whole. Pre-pandemic 14% of the listed meetings were represented by General Service Representatives; this means 85% of the meetings listed are likely to be out of the communication loop. The numbers and varieties of meetings appearing on the websites of each central office are displayed. It is noted the total of the Post Pandemic meetings is 29% of the number listed Pre-Pandemic. What this means for the number of represented groups is unknown. I want us all to think about what this may mean for the future of AA and its service committees. (This table was created on 8-25-2020. The data changes daily.)

It has now been 10 months since this motion was first heard by our assembly. This motion was met with strong objection by the Treasurer and Finance Committee. This motion directs the Finance Committee members to have access to all the area's financial information so they can insure GSRs are provided with accurate, detailed, and easy-to-understand financial reports. If GSRs do not have accurate, detailed, and easy-to-understand financial reports, GSRs cannot inform their groups on the 12-Step work performed by the area.

Groups need to understand how to participate in local 12-Step work, which includes their responsibility to AA as a whole. AA areas are the entities of the service structure that serve their local groups by performing the 12-Step work in their local geographic area. GSO is simply the resource provider of literature, service materials, and other information in order that assists areas in their 12-Step activities. GSO does not do 12-Step work. 12-Step work is performed by the standing committees of local areas. Like GSO, Area Assemblies and Area Committees are necessary to simply provide the structure for the coordination of 12-Step work.

I saw three key reasons for submitting this motion:

- 1. In the 10 years I have been in service to this area, the area inventories have consistently and repeatedly held the voiced request from GSRs for accurate, detailed, and easy-to-understand financial reports. The failure to respond to this request means the area is ignoring the key principle of our service structure the Right of Participation. If GSRs do not understand the work of the area and how its money is spent, they cannot inform their groups on the work of the area or AA as a whole.
- 2. 12-Step work maintains AA as a movement. Its performance keeps our membership active in their sobriety while they extend the hand to those who will grasp it in the future. The area continues to expand its 12-Step work. Our area currently has 14 service committees. The area directly finances 12 of those committees, and the body of the assembly is considering the proposal to add another. Let's think about how the delivery of accurate, detailed, and easy-to-understand financial reports would assist to replace the fear and confusion in growing the area's 12-Step work. Reliable financial reporting would help to include the balance of cash available in the checking account as well as the budget. We need to replace the reaction of confusion and fear of growing 12-Step work with the confidence provided by the details of the total work performed through the support of the groups.
- 3. Rotation of our voluntary service workers is the <u>primary</u> reason for this motion. GSRs, you have a vital decision to make on this proposal because adopting this set of duties, or even simply making them an experiment, directs the work of the currently serving Treasurer and Finance Committee members as well as those who come in the future. It is the groups through their GSRs who direct the work of the area in creating accurate, detailed, and easy-to-understand financial reports.

The work outlined in this motion simply allows the members of the Finance Committee to access the area's financial information for their participation in creating accurate, detailed, and easy-to-understand financial reports. The duties in the motion are simple, commonly-found accounting practices used in any responsible organization. Most of us are familiar with asking someone to proofread our type-written reports. The duties in this motion essentially allow the Finance Committee members to proof-read the area's finances and assist GSRs by developing and delivering to them the accurate, detailed, and easy-to-understand financial reports they need to inform their groups on the 12-Step work activities of the area and AA as a whole. The adoption of these duties helps to insure the Right of Participation, which is probably the primary spiritual principle of the service structure is practiced in all the areas affairs.

Passing of this motion simply allows the Finance Committee members in this and future rotations to access the area's financial information. Without inserting these duties into the guidelines, future rotations will not be informed of this work assignment and the access to the financial data. If this motion is passed, the Area Chair will be asked to appoint an Ad hoc Committee to initiate an implementation process. This will take a lot of work and provide an active partnership with GSRs in order to serve their informational needs. The reporting on the active exploration process will provide insight into all the work the area has been doing as well as discovering new ideas for 12-Step work.

Currently we have two motions regarding our Area 8 treasurer positions (currently a Treasurer and an Alternate Treasurer) which are coming before the Assembly for a final vote to be included in our Area Structure & Guidelines.

Motion J: To Change Titles, Duties and Responsibilities of the Treasurer and Alternate Treasurer

Motion P: Treasurer and Accounts Treasurer Responsibilities

While it is certainly possible to choose to adopt neither of these motions, in which case the Structure & Guidelines would not be changed and we would continue on as we had before, what is NOT possible is the adoption of BOTH of these motions. In essence they are competing with one another. Because of the nature of our approval process (substantial unanimity defined as a 2/3 majority), it becomes necessary for the Assembly to first choose between the two, which of the motions it wishes to vote on for adoption. Therefore we have elected to conduct a Preference Vote between the two motions. It is most important to note that a preference for one motion over the other DOES NOT necessarily mean supporting the adoption of that motion, simply that it is preferred over the other alternative. Only the FINAL VOTE on the chosen motion will determine whether or not it is adopted.

We do not wish to insult anyone's intelligence here, but we will present a hypothetical example in order to better explain the Preference Vote/Final Vote process.

Assume that the Area has an official ice cream, defined in the Structure & Guidelines as Fudge Ripple. Assume that there are two motions put forward to change that, one for Strawberry, and the

other for Mango Sorbet. Should you (your group) support the change to Strawberry, wanting it to become the official ice cream, you would vote for it in the Preference Vote and, should it win the Preference Vote, vote for it to be adopted in the Final Vote.

However, should you (your group) be in favor of retaining the Fudge Ripple, not changing the Structure & Guidelines, we would ask that you still make a choice between Strawberry and Mango Sorbet in the Preference Vote, but then you would express your support for Fudge Ripple by voting against adopting the winner of the Preference Vote when the Final Vote is taken.

Perhaps this has helped make the process clearer, but if not, perhaps it has sent you to the freezer for some cool refreshment.

Guest Speaker-Dr, Al Mooney, Alcoholics Anonymous Class A Trustee

Al Mooney... grateful member of Alanon, Class a Trustee of AA. Being a friend of AA is how I identify myself. Wonderful to watch the process of what we do in service. I am struggling with the adaptation of virus times. What other times could we have the opportunity to visit other places like we do now via the internet. Going to Ghana and experiencing the issues of getting AA started in that area. One of the things I hope to convey as a non alcoholic trustee is the power of the fellowship. My Dad was a paratrooper in WWII, he went to prison and was introduced to AA. Dad was injured in the war and that is where his problems started. Al was introduced to AA through his dad. When his dad disappeared his family would tell him he was off learning to be a better doctor, when he was actually in prison. His dad became involved in prison with a group called addicts anonymous, forebearer to narcotics anonymous. In the 50s when his dad was having trouble there were not a lot of options available to get help. When his dad came home he told AI that he had been in prison. For some reason hearing that lifted a burden from AI, today he realizes that it was hearing the truth, the truth will set you free. His father was

a new man from the one he remembered. How did a new person get put into his dad's body? This is referred to as the psychic change? Since his dad was a doctor and his mother a nurse, they treated a lot of alcoholics and even started a treatment program. Because his family was immersed in the culture of AA he began to get involved in Alateen. Al does not drink, something about the experience of his family kept him from becoming an alcoholic. He asked a psychiatrist how a sociopath becomes a philanthropist. He was told this was not possible and that he shouldn't waste his time on alcoholics. His role as a non-alcoholic Trustee is being of service to Alcoholics Anonymous. With just a little over a year into his tenure as a trustee, he hopes to build on his friendship with AA. Was doing classes online with Ghana in west Africa, when covid hit they decided to turn it into an AA meeting. He has heroes in AA where he is able meet them via on-line meetings. Guy, an alcoholic from his hometown, Statewood, GA, used to say he came around AA for the huggin, the kissing and the fried chicken. After reading the Service Manual Dr. Mooney realized how important those non-alcoholic members of GSO were to AA. Bill W. is pretty specific about some leadership that was needed when AA came of age, which is why there was a need to maintain non-alcoholic trustees. As a physician he has had to learn how to utilize the Big Book to help some of his patients. Nothing in AA that conflicts with modern science. Seven Class A trustees from different professional areas, he is the only medical doctor currently. I appreciate the opportunity to be here and share with you today. //John-Archives. Being a physician, I'd like to hear more about discussions with science and evidence based therapy. // Many people, even non alcoholics will find the AA book useful. Medical people do not even pick up the big book, no man's line between the two. As of March, The Cochran library says that AA is more cost efficient treatment. Science has begun to describe the positive changes when we promote healing, the psychic change. Wonderful rat research, alcoholic and non alcoholic rats, alcoholic rats have inability for out of the box thinking. Learning defect., Element of AA that is most important, happy, joyous and free. Why should medicine just make people normal again, why stop there, why not try to make them better then normal? Until recently that has not been on the radar. Scholars are trying to define happy, joyous and free on an academic level. Emotional sobriety and a citizen of the world, putting something back into the world.//Riley, theory of the allergy.// executive function, innate immunity. Allergic reaction. //Richard, 13th step, anti AA. Do you have a short read to hand these people.// Science is not what drives these people. Dr Mooney considers it malpractice not to offer AA. We do the 12th step after talking the 5th tradition, love when people challenge him because he always comes out better in his beliefs.//

All of the Alt Delegates from all 93 areas meet recently. I wasn't able to attend. I missed the first one. They plan on meeting on the 1st of every month. They will be collaborating on ideas of how to get through the pandemic and what roadblocks we have encountered.

The Alt Delegates from the Pacific Region have been communicating as well. We have been communicating on various topics that are affecting our areas.

Chairperson's Report-Blaine H.

Today will be our third area assembly conducted remotely. Many thanks to our IT Chair Chuck, our Webmaster Karen, our Delegate Jerry, our Registrar Bill, and all the others who have contributed to making these events run as smoothly as possible. There is a lot that goes on behind the little windows where we see our friends. At the present time the virus still has the upper hand and for the near and even the moderately distant future, Zoom is here to stay, and, as always "Acceptance is the Key...!"

Along those lines, I know that many of you were able to attend the excellent Town Hall put on 8/27 by the Three Legacies Group. How does and will Alcoholics Anonymous cope with the ever-changing requirements of dealing with the pandemic. An Area ad-hoc committee has been formed to study this question and come up with ideas and recommendations not only for our groups but also for all of our service entities. If one is interested in joining this effort, please let me know.

Between now and the end of the year we will be focusing on our area standing committees. The viral shutdown has been particularly hard on them and their ability to carry out important 12-Step work. It has been heartening to hear that at least as far as Hospitals and Institutions are concerned, that there has been progress. While correctional institutions have understandably completely shut down, the message is being carried into treatment facilities, a few in person on a limited and restricted basis, and an increasing number through Zoom. North County H&I has developed a regular H&I panel which can be signed into by multiple treatment facilities. SDIAIC (San Diego H&I) will be debuting a monthly virtual orientation session on the $17^{\rm th}$ of this month.

Financially the area is facing a rather unusual problem. Because a lot of our budget goes to live events and activities requiring travel which is reimbursed to members on the basis of mileage, those funds are not being spent now because of the COVID shutdown. Also our assemblies and committees, for which rent is a significant cost, are all now meeting virtually. Bottom line is that we have budgeted funds which are not being spent and will not be spent this year. You will hear more about this a little later today from our Treasurer and Finance Committee Chair. Making a large end of the year sendoff to GSO would not be wasting these funds, however finding creative ways to expend them for good purpose within the Area would also be a good solution to this unusual problem.

Also on the financial front, the shutdown will also affect the 2021 budget which was prepared based upon the requests submitted early this year – before the full effects of the shutdown were known. It is of utmost importance for GSRS, DCMs, or any interested A.A. members to attend one (or more) of the budget workshops which are scheduled to take place between September 2^{nd} and October 31^{st} . A flyer with the dates is on the area website. Please be prepared for action at the November Budget Assembly (11/7/20).

Lastly please remember that the Area Survey is still going on but will end 10/15. The flyer with links to both the Member and Group portion are posted at <area8aa.org> as well.
