Despite the drawback we recently had the pleasure to experience two great events in a virtual setting. ROOTs, with a new interview format, was a trip into the past and brought back lots of fond memories for many of us. And the Hispanic Women's Workshop last Saturday was remarkable. It was my first time "attending" one of these and all the shares were great. The translation, largely done by Area 8 members, was fantastic!

With the practice of the spirit of rotation, the new year will bring lots of new faces to our screens. I wish to thank all those rotating out for their service during these difficult times. Hopefully this will not be the end of your General Service experience. There are many opportunities still out there. If you are departing following a stint as a DCM or Standing Committee Chair, remember that you are eligible to stand for election to an officer position next September. Don't be a stranger.

Tonight you will hear of plans for increased involvement of our standing committees at the Orientation Assembly. Although membership on a committee is considered one of the responsibilities of being a GSR, it doesn't appear that always happens. At the January Assembly the new (and old) GSRs will have a chance to interact with the committees during round tables. Also, as opposed to the "blind pick", GSRs will have more choice in a committee assignment.

Also on the agenda will be a motion to adopt the amended Structure and Guidelines that have been undergoing revision by the Policy Committee with input from the parties involved. Agreed, you will not have had a chance to digest the extensive document and it is possible that the Spanish version may not be currently available. Please remember that all

motions that go through this body go on to an assembly whether or not they are "recommended" by the Area Committee. The reason to present this now is that it then can be presented at the January Assembly for a vote to take it to the groups. There will be ample time to study the document between now and then.

The Four-Area DCM sharing Session is an annual event with the four SoCal areas (5, 8, 9, and 93) participating. As you may recall this past year the event was held June 28<sup>th</sup> and was hosted by Area 93. We will be hosting the event in 2021. I had Areas 5 and 9 on board for a February 28<sup>th</sup> date but just received word from Area 93 that this represents a significant conflict with their Spanish community. We are now looking at a summer date possibility involving less conflict with the Conference season.
