#### 1. Will your standing committee meet in person or virtually in 2022?

The Grapevine / La Viña Committee (GV/LV) will meet virtually for 11 meetings and have 1 meeting in person. This goal will be to have this in a member's backyard or local park.

# 2. Does your standing committee have needs not addressed in the barebones spending plan dated 19 April? Please describe those needs and detail the funds required?

The Committee requests an additional \$180 for the following:

- \$30 for parking fees at the Spring Roundup The Committee runs a literature table during the entire 3-day Spring Roundup.
- \$150 for the Chair to attend PRAASA -- There are generally two or more Grapevine / La Viña meetings or workshops at PRAASA plus multiple opportunities to meet and network with other GVLV chairs, learn effective strategies for innovation and strengthening committees, and new developments in Grapevine and La Viña on an international scale.

The Committee will need Spanish translation at the virtual Writers Workshop (3 hours) and at the Grapevine / La Vina Representatives training (2 hours). We will also need ASL interpretation at the virtual Writers Workshop (3 hours).

# 3. Does your committee have any special events planned for 2022 that would require funding in addition to the funds provided in the barebones spending plan? Please detail the event and funding required.

Yes. The work of the GVLV Committee includes presenting workshops and trainings that involve local members with and build support for the Grapevine and La Viña international magazine, the GVLV YouTube Channel, and other medium. These activities also support the role of the Grapevine and La Viña Representatives bringing GVLV information and literature to their meetings. Total workshop and training expenses are estimated at \$966. We will approach the Districts about co-sponsorship to help defer the costs. Our hope is to raise \$300. The total amount for workshops and trainings would then be \$966.
