#### **Motion for ASL Interpreter Pay Increase**

Good afternoon; my name is Jeffery, alcoholic and the Accessibilities Chair.

## The Accessibilities Committee would like to make a motion to increase the pay rate from \$50 an hour to \$65 an hour for ASL Interpretation.

Area 8 has been a Pioneer in providing ASL Interpreting for AA meetings. In addition, the Signs of Life (SOL) program offers comprehensive outpatient drug and alcohol treatment for Deaf, Deaf-Blind, late-deafened, and Hard-of-Hearing adults. SOL is the only community-based substance abuse program in the United States that is designed specifically for Deaf and Hard of Hearing individuals. SOL provides individualized treatment and recovery plans that meet the individual's unique needs here in San Diego and presently have two recovery homes for Men.

In 2008, the Accessibilities Committee established the Sign Language Fund / The Gold Can. This fund collects contributions from groups and individuals to pay for Certified ASL Interpreting services for AA meetings and events. The Gold Can, can pay the cost in full or half with the meetings paying the other half. As a result, some AA meetings have decided to be self-supporting, allowing help for other AA meetings. Pre-COVID we had 11 ASL Interpretered AA meetings weekly; 4 were self-supporting, and 7 that the Gold Can helped pay for ASL Interpreting. During COVID we had 8 Interpreted meetings; 3 were self-supporting, and 5 that the Gold Can helped pay for. Presently, we have 6 interpreted meetings, 3 are self-supporting and the Gold Can helps with the other 3.

In 2015, we realized that there wasn't a standard pay rate for ASL interpreting services at AA meetings. Some meetings were paying a rate under our current rate, and 1 1/2 hour-long meetings were only paying \$50 which is strenuous work for 1 interpreter.

In 2016, a request to pay ASL Interpreters \$50 an hour and \$75 for 1 1/2 hour was motioned and approved through Accessibilities Committee.

Before 2016 Accessibilities Committee and Area schedule interpreters separately so there was no approval from the area or groups. In 2016, there was a request to our Accessibilities Committee to schedule an ASL Interpreter for an Area Assembly and so from that moment on our ASL Interpreter Coordinator has been scheduling Interpreters for all Area Events (Assembly, DCM Sharing, District Meeting, and Unity Day) as well as regular AA meetings.

(There is an additional layer of specialized knowledge of the AA terminology, idioms, phrases, ethics, and general life skills. Large urban areas tend to pay higher whereas smaller cities will pay less. In a remote setting, there are extenuating circumstances. For an hour meeting, with the fast reading of the frozen text of chapter 5, prayers, traditions, and literature plus the continuous dialogue of people speaking, there would generally be two interpreters for \$50-75 for each individual. Additionally, the interpreters receive a two-hour minimum each. In this sense, AA has been paying interpreters 1/4 their worth for years. They have been doing this service out

of their sense of humanity and their hearts. These interpreters also have full-time work and possibly develop body pain (carpal tunnel syndrome) because of the stress to do an accurate Interpretation for the deaf alcoholic. ) We have done the research and have found that Deaf Community Services here in San Deigo, pay rates are as follow:

Weekdays Rates - M-F Day \$75/ hr - 7-5 pm Night \$85/hr - 5-8pm Overnight \$95/hr -

Weekend Rates
Day \$85/hr - 7-5pm
Night \$95/hr - 5-10pm
Overnight \$105/hr
Special services for the Deaf-Blind, Legal, Trilingual, Last-mintue and Holiday add an extra \$20.00 per hour.
