<u>General description of what the Treasurer does:</u> Attend Finance Committee meetings on the 2nd Monday of each month. Pick up mail from the Area P.O. box. With the aid of the Finance Committee, creates a budget for the following year (2018). Also smooths out and finance issues that come up throughout the year.

How the general service board fits into the structure: We have 21 trustees. Those trustee are broke into 2 groups. A and B. A Trustees are nonalcoholic and B Trustees are members of AA. Trustees meet 3 times a year. The beginning of the AA structure began back in the 1930's. In 1938, the Alcoholic foundation was formed. In the late 1940's Bill, Bob and other founders came up with the idea of an Annual Service Conference meeting was born in hopes that the message of AA would be carried on to future generations. In 1951 the first General Service Conference was help. In 1955 the General Service Conference was adopted as an annual event.

- O **Policy**: Cecil L.-Welcome to new GSRs. We maintain and overlook the Structure and Guidelines at the Area Level. We need to have structure for our Area. We meet first Monday of the month at Central Office. We review flyers for the Area that are posted on the website and assist new members in putting flyers together for their events. Quoted the need for Alcoholics Anonymous to be there for the new members of our program.
- Translation: Maire H.;I just want to announce that the translation committee is accepting nominations to Area 8 Translation Committee Chair and Alternate Chair service positions. On July 1st, 2018 the current chair and alternate chair will rotate out of these service positions. Written translation of ACM reports, reports of Delegate and Alt., Pacific Regional Trustee Reports, GSO reports, so that all our district reports are included in both English and Spanish. We use translation programs to assist in translation. We work at home and welcome all persons to help this committee. We have made numerous friends in the Spanish Community. We meet every two months and have a meal and discuss any issues.
- San Diego H & I: Blaine H.- SDIAIC (aka H&I) would like to thank the Assembly for the opportunity to share our purpose with the new GSRs and the Assembly as a whole. AA members have been doing H&I work here since the inception of Alcoholics Anonymous in San Diego in 1940. Since 1974 we have operated as a financially free-standing committee of Area 8 with a vote at the AC and the Assembly. We appreciate the efforts of the Area to support our work in "carrying the message" and always support the Area's efforts to do the same. H&I Takes AA meetings and AA literature into places where people can't get out to go to meetings jails, prisons, hospitals, etc. We hold orientation on the 3rd Sunday of each month at noon in the Machinists' Hall 5150 Kearny Mesa Rd, and the 3rd Thursday of the month 7:00 PM at San Diego AA Central Office. Our subcommittee, Contact on Release, matches people being released from these facilities with AA volunteers who take them to meetings in their local area. It meets at the Machinists' Hall on the 3rd Sunday at 10:30 AM. We are excited about the 2018 SoCal H&I Conference which will be held April 6 8 at the Four Points Sheraton in Ventura. Our Saturday Keynote Speaker will be Scott Kernan the Secretary of the California Department of Corrections and Rehabilitation who appeared on 60 Minutes with Oprah last

October. <socalhandi.org>. We ask new GSRs, and in fact all who get this message, to please carry the word back to their groups that H&I always needs new volunteers – as panel members, as Contact on Release volunteers, AND to serve on our committees that coordinate and facilitate their work. It is important that folks realize that H&I work can be done in addition to ANY other service commitment one might have. There are no restrictions based upon one's current position. Also we ask that groups be reminded of the 5th Tradition – *Each group has but one primary purpose* – *to carry its message to the alcoholic who still suffers.* An AA group can adopt an H&I panel and fulfill this purpose. If that is not possible the individual AA member can become a panel member and/or Contact on Release volunteer. The opportunity to serve is always there. Balance that triangle.

- North County H & I: Suzanne: Duties are the same as above. We bring AA into Hospitals and Institutions in North County. We have a orientation coming up on Jan 29. Please come join. Our website is nchi.org
- YPAA Adhoc: Riley; The area approved an ad-hoc YPAA standing committee and we need your help! If you are young, young at heart, or just looking to be of service, our goal is s to bridge the gap between young people and general service. We meet the 1st Tuesday of each month in North County. Our 1st event will be held in March 2018. More info and details to follow. YPAA is an acronym that stands for "young people in AA," and YPAA committees typically host events for young people to show them they can have oodles of fun while being sober. However, for many young people, general service isn't "lit" enough for them to participate! That's where we come in.

While I am there I will be asking if they would like to have an assembly in Brawley this year. It is important that everyone in our area feel involved.

<u>Delegate's Report: Roxane:</u> Welcome to the first Assembly of the new year and the new panel, Panel 68. I am privileged to serve you as your Delegate to the General Service Conference. If you are not sure exactly what that is, you may want to ask a few questions today. I have come to realize there are many people in the program of Alcoholics Anonymous who have no idea about the scope of a Delegate. Today we can begin to shed light on any myths and misconceptions of what we do here.

Thank you to our host districts for making today possible. Thank you for everyone who got up early this Saturday morning, dressed appropriately, possibly carpooled, and arrived here ready to orientate themselves to the work we are doing. If you are a new GSR, I hope you attended the GSR School this morning. If you did you will be receiving your first star towards becoming a 5 Star GSR. If you want to learn more about that coveted title, please see our Alternate Delegate, Jerry S.

I don't believe there is anything more sobering than a morning spent in the Oncology Department of Balboa Hospital. Yesterday, the first day of intravenous Chemotherapy for my mother, was met with a large measure of trepidation but also a remarkable dose of hope. How can you not venture into unknown territory without hope? I believe hope is the gift of a Higher Power so that we can bear what lies ahead. Once the disappointment of my mother's diagnosis was accepted, I believe hope seeped in incrementally. That hope remains today and fuels me for tomorrow.. Martin Luther King Junior said, "We must accept finite disappointment, but never lose infinite hope." Today, as we listened to many of our trusted servants reveal the work they do and aspire to do, we can rest assure, our hope is infinite. I imagine this transformative hope is what has sustained Alcoholics Anonymous since it's conception.

The 2018 General Service Conference is upon us. I have been assigned a committee and a Conference Buddy. My Committee is Agenda, and my Conference Buddy is Marjorie from Missouri. I am ready to explore the theme of the conference: "A.A. – A Solution for All Generations," and the topics:

- a. Today's Alcoholic: Inclusion, Not Exclusion
- b. Participation in All of A.A. Is My Triangle Balanced?
- c. A.A. Technology: Where Innovation Meets the Traditions
- d. Attraction Not Promotion: A.A.'s Relation to the World
- e. Group Conscience: The Guiding Force

The workshop topic will be "Getting the A.A. Message Out." When the agenda topics are revealed we will look at them from this lens. We will begin our work at PRAASA, March 2-4, and I encourage you to attend. The Reno location makes it affordable so talk to your groups or districts about funding this event. The next week the first of 3 Pre-Conference Workshops are beginning. These are designed to show you how to present ideas to your group members so we can gather an informed group conscience related to the topics

I mentioned. Please look at the calendar for a Pre-Conference Workshop that suits your location and time. Flyers for all three workshops will be available soon. Remember, this is what you elected me to do and I am adamant about having you be part of this informed group conscience.

Last Sunday the San Diego Union Tribune ran a front page article entitled *Medical Revelations* from "Death Diaries." The article tells of a San Diego doctor's examination of deaths from drug overdoses which found patients mixing substances, long histories of people hopping from provider to provider, and well-meaning physicians who had no idea what was happening. If there was ever a better time for our committee, Cooperation with the Professional Community to be doing service work, it is now. If you have even a remote desire to contribute to the work we do here in Area 08, please sign up to become a member of one of our committees. Your sobriety will be enriched in ways you never thought possible. I have been a part of CPC, Agenda, Policy, H & I, and IT. I loved the work we did on the IT Committee.

The Regional Forum happens every two years in Region 9, the Pacific Region. This year it is taking place in San Jose, California, Sept. 7-9, 2018. I have been fortunate to attend several regional forums in my years of general service work.Regional Forums originated in 1975. They were to be weekend-long sharing and informational sessions designed to help the General Service Board, A.A. World Services, Inc., the Grapevine Corporate Board, the Grapevine Staff, and the General Service Office Staff stay in touch with A.A. members, trusted servants and newcomers to general service throughout the A.A. service structure. As all Forums are intended to be sharing sessions, no formal actions result. Sharing at Forums is captured in Forum Final Reports which are distributed to all attendees. Regional Forums Final Reports are available on G.S.O.'s A.A. Website. Forums provide unique opportunities to share and exchange valuable experience, ask questions and spark new ideas. Regional Forums and Local Forums carry A.A.'s message of love and service by improving communication at all levels of our Fellowship.

General Description of what a delegate does: The man or woman elected every other year to represent the area at the annual Conference meeting in New York and to bring to the area the results of that meeting (Service Manual S20). The delegate has a demanding job, not only because a large amount of time and work are involved, but because it is the delegate's responsibility to serve the US/Canada Conference as a whole. As voting members of the Conference, delegates bring to its deliberations the experience and viewpoints of their own areas. Yet they are not representatives of their areas in the usual political sense; after hearing all the points of view and becoming fully informed during Conference discussion, they vote in the best interests of A.A. as a whole (S49). The delegate's job goes on year-round and involves all aspects of the Conference structure (S49).

Alternate Delegate's Report: Jerry S.

The duties of the Alternate Delegate will be to perform:

- 1. The duties of the Delegate in the Delegate's absence
- 2. Other duties as requested by the Area Assembly

The alternate Delegate serves as a valuable assistant, often traveling with the delegate or giving reports for him or her. In some areas, the alternate serves some special function of the committee. An alternate who replaces the delegate at the annual Conference meeting will remain on the GSO mailing list as the delegate until GSO is informed otherwise by the area committee".

Jerry- "to assist", to liaise to specific standing committees, to liaise to the Southern California Convention (putting a panel together on General Service), to coordinate Unity Day, to conduct the "New" GSR Orientation (class sessions, as re-created by Jerry) at each Assembly, advance new technology forums between all Areas.

Area Inventory: Jerry M.;; Last August we developed an area inventory. We looked at what we are going in the area, better ways to serve the area, how d we conduct committee work, are area meetings meeting our needs? And prioritized the issues that need to be addressed. After that, we developed AD Hoc Committees. These Ad Hoc meetings have been meeting to come up with recommendations to address issues liked the ones mentioned above. Later in the year these recommendations will be presented to the area in the form of a report.

Old text: 5. Standing Committees will be composed of up to nine (9) voting members, each of whom will be members of the San Diego-Imperial Area Assembly. Except for the Chairperson, a member's term of service on a Standing Committee shall coincide with his/her term of service as a GSR or a DCM

<u>Proposed text</u> (includes text rewording and grammatical changes) 5. Standing Committees will be comprised of voting members and volunteers. Committee Members will be made up from the group members of Alcoholics Anonymous of the San Diego-Imperial Area. Voting members of all Committees will be selected in accordance with the Structure and Guidelines of the Standing Committee they are selected to. Voting membership on a Standing Committee means that they have voting rights pertaining to Committee business on the committee they serve. A members' term of service shall not be greater than two years on any one committee. All other members of any committee are considered volunteers.
