The Committee was called to order at 7:00 pm by Blaine, Area 8 Chair-, with the Serenity Prayer. Followed by the Declaration of Unity.

September minutes were approved unanimously.

Treasurer's Report: Cheryl F.

Happy Halloween to you al! I have a ghoulish report for you. (Aren't they all rather ghoulish and boring?)

This is the last report I have for you before the Budget Assembly in November. This one is going sound a lot like the last few. I want to make sure you are well informed so that when we meet next month at the assembly our group conscience is an informed decision. I can not tell you exactly what the numbers will look like come December but these past few months reports will give you a general idea.

At the end of September, we had \$37,926.02 in the bank. \$5,000 of that money is our prudent reserve. This number has remained constant each month since we have not had a reason to use those funds. Our operating budget will then be \$32,926.02. If this was the end of the year (December) and I had to prepare our accounts for 2022, I would start by subtracting the unspent 2020 reallocation money and sending that sum to GSO. Referring to the September finance report, our unspent reallocation money equals \$3,021.50. This money was targeted to be spent locally in 2021 instead of sending it as a 2020 contribution to GSO. It will be retroactively sent to GSO. Bringing the actual 2021 finances to \$29,904.52.

According to the current Structure and Guidelines I will need to retain \$11,795.75 which represents

one quarter of the 2022 spending plan. This is the money that we will use to pay our expenses for January through March. This is another number that has remained constant over the last few reports. Finally, I will subtract the money that represents uncashed checks that have as yet been processed.

On September 30, we had \$250.73 in uncleared transactions.

\$29,904.52 (2021 finances)

Minus \$11,795.75 (first quarter operating funds)

\$18,108.77

Minus \$ 250.73 (uncleared transactions)

\$17,858.04 (2021 surplus)

This gives us a surplus of \$17,858.04 which by Structure Guidelines is forwarded to GSO as a contribution from Area 8. Over the last five or six months we have been requesting projects for a possible 2021 reallocation. Tonight, we will be discussing further reallocation proposals. Please pay attention to these proposals and discuss them with your districts. We will be voting on a 2021 reallocation at the November Budget Assembly as well as approving the 2022 budget.

I will now answer any questions you may have regarding the August finance report or the information I covered in this report.

Participation was immediately impacted and our ability to fulfill our purpose and connectivity with our groups suffered. I've been taught by those that have gone before me, that any problem in service is really just a problem of recovery and that any problem of recovery can be overcome through the primary principles we hold dear, none so vital as an honest, fearless and thorough inventory.

I know we will entertain a report on our upcoming Area Inventory, but I wanted to ensure I shared my two cents on this vital and caregiving exercise to the pathway of our Area moving forward.

- What have we learned, what have we lost?
- What assets and successes need massaging and what practices need excising?
- How are we coming up short in serving our groups; what is handicapping us?
- I pray that you have prioritized this three-hour event in just over a week from now. Its vital that all of us attend and bring an open heart and open mind. Its not up to me. Its not up to you. Its up to we. Its up to us to define what unity means today. Its up to our shared experience strength and hope to define what the hand reached out to the suffering hand of alcoholism looks like today and into the future tomorrow. MOTION: Create a Procedure for Business Without a Quorum - Jerry S. Jerry's motion is a proposed amendment to the Area Assembly Structure and Guidelines.

Name of Motion: Addressing Lack of Quorum

Motion: It is moved that language be added to our Area Structure & Guidelines to assist the Area in its proceedings in the event that a quorum is not established. (see 1 - End Notes, pg.)

Current Text: N/A - There currently is no text regarding procedure that ought to be taken if a quorum is not achieved.

This motion will go to the Assembly. We (the ACM) will either recommend it or not recommend it. In order that the body will have a method of doing business, of having elections, and of making

decisions at our Budget Assembly we will consider a vote of confirmation by simple majority.

The motion passed:

48% in favor; 43% opposed; 4 abstentions.

Jerry described it as a temporary circumnavigation due to the apathy in general service.

The Policy committee does not endorse the motion.

Hello Family,

As I continue on this journey, my willingness grows stronger everyday. Since last month, so much has happened or changed. Our elections at the end of the September were conducted. This area has decided that I will make a great asset to the structure of this area. I am grateful for this opportunity and look forward to continuing to serve AA. A special thank you for Dean B and all the invited guests for standing in and helping out with the GSR School/Orientation.

I got to be in two places at one time. For those of you who know me, you know I love camping. I try and attend this campout at Lake Henshaw every year. I was at the AA camp out while the elections were being conducted. I was surrounded by some of closest friends. It was a wonderful feeling. They were there to cheer and give me support where needed.

Some of you joined me along with the Central Office crew for Unity 2.0. This was a day to be outside and celebrate recovery. We felt like the event was successful. I would like to personally thank each and every person that showed up, helped out or participated in some type of way. The camaraderie and laughs can still be felt weeks later. They knew they would have some but didn't know when.

Area 9 has some of the same issues that we have. For some of the positions, there was only one person standing. This has never happened in my recovery. I didn't know what to do. I was standing in for Kathy and almost messed it up. We got thru it and completed the elections process. With less people standing for positions, this raises questions: 1. Why are our members not interested in standing for an officer position? 2. Has Covid played a role in members not getting out and participating in the service structure? 3. Is AA losing its attractiveness? 4. Is there something going on that I do not know about? 5. What can I do more to encourage members to stand and participate?

These are just a few questions that come to mind. I do not claim to be able to answer any of the questions, but I would hope that this starts you to thinking about how we can have a greater conversation to help the still suffering alcoholic.

In other news, I got to visit a couple districts since the elections. District 11 and 3. It was great to speak with and interact with the members from the groups. Lots of positive enthusiasm and great energy. I am still available to visit your districts if you would like.

I have created area pin for the conference. I will be unveiling by next month.

I will be ordering more GSR material within the next few days. I will find out when we can order the new service manuals and see if we are able to get anticipated date of arrived.

I have asked service people to speak at the next GSR School/Orientation. Please respond and let me know if you available or not. I have got some responses but not all.

Chairperson's Report: Blaine H. Eng/Span.

I am sure most of you were present for the election Assembly last month. We should be grateful to those who stood and congratulate those who were elected. We should even more grateful to those who came to the Assembly without the notion of standing and later, when the need became apparent, volunteered to serve. Thank you all!

The Assembly experience also uncovered difficulty with the quorum for our body. Our guidelines clearly say that the establishment of a quorum needs to take place before we can do business. At the onset of the election – a quorum had not been achieved. At the time it was felt that, for very practical reasons, the election needed to take place on this date. Tonight, we have a motion to address what should occur in the future when a quorum has not been achieved in a situation where the assembled body feels that business should proceed and be confirmed at a later time and date when a quorum is present.

We will decide tonight as to whether our Budget Assembly next month will be a hybrid meeting or another virtual gathering. The desire to meet in person is strong, yet there are some who have told us they are still hesitant to gather in a large group even if masked (which will be a requirement for using this facility). We need to respect that view.

Earlier in the year we made the decision to hold two or three of our assemblies virtually, and the other two or three live. The decision as to which assemblies will be which has not been made. If we go hybrid next month, the degree of success of that venture may lead us to an easier decision.

In order to have successful in-person assemblies we need to be able to deploy our Area Sound System. The system is relatively new and proven to work well in the past. PROBLEM: We need a few people to be responsible for testing it, and then setting it up properly on site and monitoring its use during assemblies. It is a commitment which only require action a few times each year. PLEASE HELP!

Decidiremos esta noche si nuestra Asamblea de Presupuesto el próximo mes será una reunión híbrida u otra reunión virtual. El deseo de reunirse en persona es fuerte, sin embargo, hay algunos que nos han dicho que todavía dudan en reunirse en un grupo grande, aunque están enmascarados (lo que será un requisito para usar esta instalación). Policy Committee submitted by Chair Ernest D. October 5 and 19, 2021, discussed the upcoming 10/30/2021 Structure and Guidelines workshop. Five members present, plus Area Liaison, Blaine and Alt Delegate Monty. The purpose of the Workshop is to 1) To understand Policy Committee's efforts to date; 2) To provide a better understanding of the updated S&Gs; and 3) To make an informed decision at the November Assembly to approve/not approve the S&G. In addition, the Committee reviewed the motion presented by our Area Delegate on Addressing Lack of Quorum. The Committee did not endorse the motion. The S&G clearly states what represents a quorum. We feel that any changes to our S&G regarding a quorum, although it may offer a short-term solution, the Policy Committee strongly believes that there will be long term consequences.

1. MOTION: Create a Procedure for Business Without a Quorum.

Proposed Text:

(PAGE - 5) IV. MEETINGS OF THE AREA ASSEMBLY

- C. Voting Procedures of the Area Assembly:
 - 4. It ought to be the initial business of the Area Committee Meeting (ACM) or its Assembly to establish a quorum. Once a quorum has been established it shall be recognized as such throughout the remaining of that day's proceedings regardless of adjusting attendance.
 - 5. In the event that a quorum is not met, all business of policy and requiring vote shall be suspended until a quorum can be reached with the following exceptions: Elections and Budget Approval. Should the business before the assembly be that of electing its servant leadership, or the approval of its budget to support funding of said leadership and the assemblies collective support of direct and indirect 12 Step Work through its committees, the presiding Chair shall call for a motion to proceed with the election, should the agenda be that of elections, or the approval of its budget, should the agenda be that of managing approval of its budget.
 - 1. A second is required.
 - 2. This motion is open for discussion and debate.
 - 3. A 2/3 majority is required to pass.
 - 4. The minor opinion shall be heard.
 - 5. If this motion passes, the following practices ought to be adhered to:
 - 1. The body shall work through its agenda. However, where a vote is required, that vote may pertain to elections and/or budget approval only.
 - 2. All votes shall be recorded for a final vote of confirmation at the next Assembly when a quorum is achieved.
 - 3. A vote of confirmation of election shall be managed in the following manner:
 - A vote of confirmation of an election ought to be perceived as a ministerial/administrative act respecting of the Assembly conscience that managed the election and our 3rd Legacy

Procedure.

- 2. A vote of confirmation of an election is not open for discussion/debate.
- 3. A vote of confirmation of an election requires simple majority to pass.
- 4. With passage, the initial vote of election is confirmed for the record.

5. Without passage, an election for the respective position shall be held at the next

Assembly.

- 4. A vote of confirmation of budget shall be managed in the following manner:
 - 1. A vote of confirmation of a budget is open for discussion/debate.
 - 2. A vote of confirmation of a budget requires 2/3 majority to pass.
 - 3. With passage, the initial vote of a budget is confirmed for the record.
 - 4. Without passage, the initial vote may be reengaged for discussion/debate/vote per standard voting procedures.
- 6. If this motion does not pass, the gathering shall refrain from conducting business requiring vote

throughout that day's agenda including that of elections and/or budget approvals.

Background: In recent Assemblies there has been a struggle to achieve a quorum and proceed into the agenda for that day. Specifically, during the election assembly 2021, when unity is such a vital and important principle to be achieved, this situation led to significant confusion and argument. It is believed that by providing guidance and suggested action within our Structure & Guidelines, unity can be more succinctly reached and maintained throughout the work of our Area.
