### Area 8 Chair Blaine H

**9:50 2022 Spending Plan (Budget):** Presentation by Cheryl F., Area 8 Treasurer; Cindy H., Chair Finance followed by /Discussion/Approval. The spending plan was vetted by the November ACM. We did not accept budget requests this year. It was a decision made by the Finance Committee and the ACM. The body voted on approving the spending plan: 48 yeses in the room; 36 yeses online; 84 in favor. 3 online opposed.

This was Cheryl's presentation at the Nov. ACM:

November ACM Report, I just want to grab you all and give you a huge hug!! I am so very pleased with the 2022 Spending Plan! I wanted to stay around \$50K and we did it! I for one really like the process we used this year, including the ACM in the process. I am interested in how it was perceived by each of you and want to give you a chance to provide me, the finance committee, and the panel 72 Treasurer team with your honest opinions. I will ask for feedback at the end of this report.

At the end of October we had \$42,692.59 in the bank. \$5,000 of that money is our prudent reserve. This number has remained constant each month since we have not had a reason to use those funds. Our operating budget will then be \$37,692.59. If this was the end of the year (December) and I had to prepare our accounts for 2022, I would start but subtracting the unspent 2020 reallocation money and sending that sum to GSO. Referring to the October finance report, our unspent reallocation money equals \$3,021.50. This money was targeted to be spent locally in 2021 instead of sending it as a 2020 contribution to GSO. It will be retroactively sent to GSO. Bringing the actual 2021 finances to \$34,671.09.

According to the current Structure and Guidelines I will need to retain \$11,795.75 which represents one quarter of the 2022 spending plan. This is the money that we will use to pay our expenses for January through March. This is another number that has remained constant over the last few reports. Finally, I will subtract the money that represents uncashed checks that have as yet been processed. On September 30, we had \$2,527.23 in uncleared transactions.

\$34,671.09 (2021 finances)

Minus \$11,795.75 (first quarter operating funds)

\$22,875.3

Minus \$2,527.23 (uncleared transactions)

\$20,348.11 (2021 surplus)

Last Saturday the Assembly voted to reallocate \$12,000 of our surplus to fund unbudgeted requirements within our area. The result of this reallocation motion reallocated \$11,463. Leaving us a surplus of \$8,885.11. At the conclusion of the reallocation motion, a floor motion was made to reallocate the remaining project for \$3,500. At this time, we are on track to make a \$5,385.11 contribution to GSO from the 2021 budget.

This concludes my report and I would like to open the floor for questions about my report or to offer feedback to myself and the finance committee regarding the 2021 spending plan process.

# 1:40 Delegate's Report Jerry S. Delegate, Area 8 Delegates Report San Diego Imperial Alcoholics Anonymous – Budget Assembly 2021

11/13/2021 My name is Jerry, and I am an alcoholic and I love Alcoholics Anonymous. And I am honored to serve as our San Diego – Imperial Area 08 Delegate to the General Service Conference. And this is my final Assembly as your delegate. I am filled with so many feelings and I'll strive to bring them together at the end of my report. However, before that, let's look at some current and important pieces of information.

So, our General Service Board recently hosted its first in-person/hybrid Board weekend since the pandemic began. I have posted our anonymity protected Regional Trustee's Report to the Delegates Corner on our Area website. The report is being translated by one of our Regional Translation Committee's that did not happen to have a service event this weekend. The report will be posted in Spanish ASAP.

Many of our members and groups have been phenomenal in participating in the Carry the Message Project with our Grapevine & La Vina. This project funds subscriptions for members behind the bars. I am excited to report that there were over 2000 requests from the Corrections Desk for subscriptions. Unfortunate, however, there were only 1,200 English subscriptions and 401 Spanish subscriptions available. All went into the service of carrying the message through our meeting in print. But we need more!!! Please, bring this specific need back to your groups and help out!

In the posted Trustee Report, there is a healthy amount of information financial in nature. If that's your fix, please dive in and communicate back any questions/concerns. The rough summary is that just about all things money related is tracking on budget for the year. With one small trending exception: Both contributions and literature sales are slowly dipping these past few months. In order to remain on budget and see ourselves through the year, we need to see an increase in these areas.

Our Reserve Fund balance is \$12.8M which represents 8.5 months of operating expenses (Target is 9-12 months).

Just a friendly update regarding the upcoming 72nd GSC – The Board received 178 submitted

proposed agenda items. Let's pray that this number is trimmed down, otherwise, please begin to pray for Monty.

So, I just wanted to read an excerpt from the Sharing Session:

A non-trustee director shared that we've been struggling to make everything just like it was - only on Zoom - but we're feeling disconnected, separate, apart. It's reflected in how many agenda items are from individuals rather than coming through a group conscience -- we're not connected like we used to be. Others agreed and have heard about members wanting to bypass their delegate with agenda items. A trustee-at-large shared that there are similar problems in other parts of the world: members disconnected from their groups, not enough board members or other volunteers. Half the number of members are participating in service. She feels the Conference should talk about finding a way through this, perhaps add a day onto the end of Conference or begin with this issue to set the tone. A general service trustee agreed that we need a reset, a time out. He feels we need time together that isn't structured around arguing about who's right and who's wrong. He would love to just hear from delegates, talk together, start over with the spirituality of why we come together. A G.S.O. employee concurred that because of technology we've lost our tempo and it has thrown us off. We talk about the power of pausing in A.A. and we need to find a way we can pause as a Fellowship. It's an uphill bike ride now but it won't be forever. We just have to keep pedaling, keep practicing.

Final remarks: AA has taught me how to glean purpose through sacrifice, determination through adversity and mostly how to prioritize my truth: I am a 12 Step Practitioner. That is my spirituality and I do not apologize for it.

Thank you for allowing me to serve.

So what can you do? You can ask your district or your meeting to consider purchasing gift certificates for the Carry the Message Project. You can announce the Carry the Message Project at your meetings, and invite members to support this important project.

### 3:10 Chairperson's Report Blaine H., Area 8 Chair

It is wonderful to be meeting in person at last. I am also pleased that we are able to offer the option to attend virtually to those who may be at a distance or have health concerns. The success of the hybrid format may well lead to a decision to make this the wave of the future. Anything that can be done to boost participation will be welcomed.

And participation is the issue. I am sure that others who attended the Election Assembly in September were as shocked and dismayed as I was. Not only was there difficulty in achieving a

quorum, but there were offices for which no one eligible to stand, stood. We are grateful to those who, at the last minute, stepped up and made themselves available to serve. We thank you and look forward to your service in the next panel.

At this writing, there is still one unfilled officer position. By the time this is read I hope that will no longer be the case. I want to thank Past Delegate, Tom M., and other volunteers who helped us with the election which took place earlier today.

It wasn't that long ago that standing for an Area office was a privilege, and being elected to one a prize. Some may recall the time a few years back when suspected errors in counting the votes for Alternate Registrar created a great deal of ill feeling in our Spanish Community. And now, no one will even stand! That is how far we have fallen. There isn't much solace in the fact that this phenomenon isn't confined to Area 8. Last month at the Area 9 elections, while no offices went unfilled, there were several with only two candidates, and one with only a single volunteer.

APATHY is our enemy. We see it in all forms of A.A. service, not just General Service. I do believe that individuals and groups are still carrying out our primary purpose as I see newcomers "coming in" (some, having never been to a live meeting), getting sober, finding sponsors, and working the Steps. But what can be done about apathy regarding service?

Unfortunately, apathy does not respond to threats. There is an old Navy joke about the Captain who says, "Morale on this ship is lousy and until it improves I am canceling all liberty." It just doesn't work that way. Ours is a program of attraction, and we must make service of all kinds, but particularly General Service, attractive enough to overcome the apathy. In this effort we have enemies! The old timers who may, or even may not, have done some General Service decades ago. They complain at meetings about the "politics" or the 14 hour assemblies. One such person, who is otherwise respected by the group, can poison a room full of individuals who might otherwise be inclined to serve. I say to them – Shut the fuck up!

Some say the answer is service sponsors. Service sponsors are great, but I believe that if an AA has gone to the trouble of getting one, that person is already on our side. It is our responsibility to lead by example and action. I once took a service position because a man I knew who had about the same amount of time in the program seemed a little happier, and little more joyous, and a little freer than I was. The difference was that he did this service work. It works, it really does! So, let us all be examples of what service can do.

That, and a few more events with cakes by Jeffery, should do the trick!

PS. Blaine asked for volunteers to help transport our audio equipment. Audio Equipment Team (so far) - Kevin and Sutton and Joshua.
