A Message from the Delegate: How to Use These Summaries

This document contains the **Agenda Topic Summaries** of the background information for all of the items to be considered by the thirteen Conference committees of the 72nd General Service Conference (GSC). The topics will be discussed by their respective committees, and the committees *may* or *may not* send recommendations to the whole Conference for consideration and vote.

The **purpose** of these summaries is so that they may be used as a tool by General Service Representatives (GSRs) to provide their group with pertinent information to facilitate an informed group conscience and then to convey that group conscience to the SDIC 08 Delegate. In many cases, the summaries serve as an appetizer and those GSRs and groups with an interest in more information can obtain the complete background by way of a password-protected link on our Area website. Your District Committee Member (DCM) can provide you with the password. Please remember to **treat the background as A.A. Confidential**, and do not share it in any public forum or with non A.A. members.

Please pay special attention in these summaries to the section at the end of each topic: "What does the Delegate need to know?" Not all topics make for fruitful discussion at group level, and this is intended to help you narrow that down. Many of the agenda topics are only for that particular committee (such as reviewing a draft or progress report on the development of a piece of literature) and do not require a group conscience, but still may be of great interest to read and share. Other topics appear every year, such as reviewing workbooks and kits used by Public Information, Corrections, etc. Local committees may wish to share their experience. These summaries may also be used by other members of our Fellowship to communicate good information about the agenda topics and, where appropriate, to convey opinions to the Delegate. Any questions in this section are intended to be a guide, not a limit, for your sharing sessions. Feel free to interpret them broadly.

Your Delegate this year serves on the **Policy/Admissions Committee**. Please bear in mind that I will have the opportunity to discuss the agenda topics in that section in depth during my committee meetings at the Conference and your input on those items would be especially helpful.

What is new in 2022 is that we are in the first year of the three-year trial of the Equitable Distribution of Workload (EDW) process. If you want to know more about the EDW, there is a detailed report on this under Policy/Admissions. The key thing to note here is that there are Literature items sprinkled throughout the Conference committees to allow for more members of the Conference to share in the work. So be sure to look through all the agenda topics to see if there are any of interest to your group or committee.

Historical Context; Why is it on the Agenda?	In 2017, the Conference C.P.C. committee began discussing the potential development of a LinkedIn page for Cooperation with the Professional Community committees and
	requested that the trustees write a report exploring all aspects of this social media tool, whether it was feasible within the Traditions, and develop a potential implementation plan. A report from the Trustees was presented in 2018, at which point the Conference
	C.P.C. committee recommended the development of an A.A.W.S. page on LinkedIn that could help professionals find information about A.A., broaden the reach of the <i>About</i>
	A.A. newsletter for professionals, and potentially deepen the pool of Class A Trustee candidates.
	The 2019 C.P.C. committee reinforced the 2018 request, asking for a disclaimer that "promoted" content on the LinkedIn page was not affiliated with A.A., adding links and content referencing how A.A. cooperated with professionals, and requesting an annual report tracking how the LinkedIn page was used. In 2021, the committee reinforced this request, resulting in the progress report in the background now. This progress report notes that in the last quarter of 2021, A.A.'s LinkedIn page had 1600 followers and 1506 page views from 578 unique visitors from across multiple industries. Engagement with the content on the page ranged from 8 to 10 percent.
	Current priorities for the LinkedIn page include posting a range of content directed to professionals (including newsletters, videos directed to professionals, and employment opportunities) and expanding the use and visibility of A.A. on LinkedIn.

	confusion about spirituality vs. religion, that professionals don't know how to "refer"
	people to A.A. since A.A. has no intake process, confusion about anonymity, confusion
	about A.A.'s policy on medication (there is none), understanding who is an alcoholic,
	knowing the types of meetings that exist, confusion about A.A.'s singleness of purpose,
	and sometimes non-existent relationships with local A.A. resources. The focus group
	hoped that A.A. could clearly communicate that recovery is an evidence-based service,
	that it is accessible, and that it is inclusive.

	development, the draft Fifth Edition of the Big Book would include a new foreword, an
	updated preface, and updates to expand on existing ideas in Appendices III and V."
	There are two requests in the background that were combined into this single item. The first one cites the second advisory action noted above and expresses the sentiment that the protection of Bill's writings from the 1995 Advisory Action was taken away by the actions of the 71st Conference. They also note that updates to Appendices III and V can be via additional information immediately following the existing text of the respective appendix.
	The second submission included in this item also asks that no changes be made to the Big Book except for updating stories. The reasoning behind their proposal is that they feel that outside issues are being brought into A.A. and into A.A. literature. They quote Tradition 10 and the Preamble as well as our co-founder Bill Wilson. There is a comparison to the Washingtonian Movement and how outside issues destroyed that movement and how they feel Alcoholics Anonymous is heading in that direction. The submitter also expressed concerns on "cancelling pronouns" being the start of changes throughout the literature with of a possible progression of removing "musts" to eventually removing God.

Historical Context; Why is it on the Agenda? https://www.aa.org/resources/media?terms=twelve+steps+twelve+traditions&format=audio&items_perpage=24&sort_befcombine=title_ASC	This proposal from Texas included a number of letters from groups and districts in support and suggests that rather than making changes to the text, something like the following could be added as a disclaimer: "While the language in this text may seem dated, please remember that Bill W. wrote in the language and custom of his times. Bill was very tolerant of different individuals and members. All alcoholics, were and are now welcomed cordially into A.A. Were Bill to write this book today, it may be worded differently in some places. Society may change, but the basic spiritual principles of Alcoholics Anonymous are classic and eternal. We hope that this book continues to broaden and deepen the understanding of the Twelve Steps as written in the book Alcoholics Anonymous."
	G.S.O. received many other requests to reverse or rescind one or more of the changes approved at last year's General Service Conference, and several requests to preserve, unaltered, the text of the book <i>Twelve Steps and Twelve Traditions</i> as originally published. These requests are excerpted in the background and fall generally into the following categories: the sentiment that no changes should be made to Bill's writing, concerns that one change could lead to a "slippery slope" of endless future changes, that the COVID pandemic (or other issues) didn't allow for a fully informed group conscience, and that the changes are the result of outside issues and therefore not in keeping with Tradition 10.

Historical Context; Why	In 2021, the Grapevine committee recommended that the A.A. Grapevine Board launch
is it on the Agenda?	an Instagram account, and they requested that a report on that account be brought back to
	the Conference this year. Instagram is an online mobile photo-sharing site that allows its
	users to share pictures and videos either publicly or privately (as well as through a variety
	of other social networking platforms). It is visual in nature, allowing images to be
	displayed with or without short descriptions.
	The progress report (included in the background) reports that the Instagram accounts for
	Grapevine and La Viña launched on July 7, 2021, posting a Daily Quote each morning
	and additional posts each week (including new magazine issue releases, new book
	accounts, and inspiration from both AA pioneers and today's members). There are
	numerous examples of posts in the background. More than 130,000 people were reached
	by the Grapevine posts; the account has 5965 followers (an increase of 8.21 percent in
	the past 90 days). The large majority of followers are from the United States (with a
	handful of followers from other English-speaking countries), approximately 40 percent of
	followers are under age 45, and more than half of followers are female. Another 15,000
	people were reached by the La Viña posts; the account has 658 followers (an increase of
	6.82 percent in the past 90 days). While the majority of followers are from the United
	States and Mexico, a large number of followers come from Spanish-speaking countries in
	Central America, South America, and Europe. Nearly 45 percent of followers are under
	age 45, and while the majority of followers are male, about 35 percent of followers are
	female.

	Also in the report is a roadmap to guide workflows and address the unique circumstances of this sort of translation, including touchpoints with the General Service Conference. Of particular note is that some unedited samples of the translated text from the Big Book are

	included in this report. The committee also discussed possible alternatives to the Lord's Prayer, including the Third Step Prayer, the Seventh Step Prayer, and A.A.'s Declaration of Unity. A survey is being created by the trustees' Committee to gather wider sharing from the Fellowship regarding the use of the Lord's Prayer at International Conventions. This survey will go out through multiple communication platforms (Box 459, A.A. Grapevine/La Viña, etc.) Implementation of the survey has been delayed to later in 2022/2023.
