11:25 UPDATE on Passed Motion Reallocation of Funds from Budget Assembly

Lynn E. and Rob

Lynn explained that funds are left over that had been allocated for PRAASA (Pacific Region AA Service

Assembly), an annual in-person event. The Area sends officers and DCMs to PRAASA and pays for
registration, transportation and lodging. Districts that can afford it also send GSRs and District officers. It
was originally in person but became virtual last minute. This year there is a balance of over \$7,000.00 that

was not spent. The Chair opened the floor for discussion, explaining that decisions such as these are made at assemblies by members.

Long open discussion on the use of "targeted funds", and the possibilities of reallocating the money meant for PRAASA. Is it illegal to use targeted funds for something else?

Are we in violation of not following our guidelines when Structure and Guidelines doesn't address reallocation? Are these unprecedented times? If so, how long will they be unprecedented? Questions were asked about the balance, the specific dollar amount.

Points were made about sending money to General Service Office in NY.

Appreciation for our AA process was expressed.

There was a "point of order" asking if we had quorum. We did not. If we did we might have gone ahead and made proposals to use the funds for 12 step work locally.

Many members took part in this discussion. The Chair called time and ended the discussion commenting on the worthwhile time spent on this topic.

Committee Chairs

Kenny H, chair of the CPC (Contact with the Professional Community) Committee meets on the 4th Monday of the month at 6:30pm.

- Meetings are virtual via Zoom
- We currently have three members (including the chair) and would like to add some additional members this year
- Activity and engagement with the professional community has been very low since the beginning of the pandemic
- There is a great opportunity to ramp up our proactive efforts and we will be identifying our key priorities for 2022 during our meeting on 1/24.

Parker, Chair of the Grapevine / La Vina Committee. Our committee informs assembly members of all Grapevine and La Vina publications, audio-visual materials and other special items that are available to the fellowship. We increase awareness of the way Grapevine and La Vina materials carry the message to our fellowship, including remote communities, and hospitals and institutions.

Lastly, we assist the Area delegate and the Area assembly on Grapevine and La Vina matters, including relevant general service conference agenda items. We accomplish this primarily by holding workshops, like writing workshops to encourage folks to write and contribute, to submit articles to be published, potentially in the Grapevine and La Vina magazines. We also attend events in person, and virtually where we display Grapevine and La Vina materials that are available. We are in need of folks to help us do this 12 Step work. So if you're interested well hope to see you that around table later. Thank you.

Tiffany, Chair of the Armed Services Committee. Our mission statement: To carry the message of Alcoholics Anonymous to service members, veterans and their families by organizing personnel and assets in our community and forming new relationships with our military communities. You may not be aware of it,

but we approximately15 military bases in Area 8. I say the short version of our mission statement is that we carry the AA message to the still suffering alcoholic in military uniform. Our committee is open to anyone. You can be 100% civilian. We are in need of people who have military base access. We will go on base and start AA meetings or support AA meetings if they already exist. We will speak at internal briefings, if invited, and will present what AA is, what AA is not, and how and where to find AA. We created a standard AA PSA (public service announcement) for each branch of the military. Please reach out me and the Armed Services Committee. We would love to have you join us.

Paul, incoming Archives Chair. I would like to thank John, the outgoing Archives Chair for his service, and coming to North County to turn over the binder and show me the ropes and how everything works. I want to reach out to the new GSRs who are attending. The Archives Committee hosts the Remembering Our Old Timers (ROOTS) workshop every year in November. If AA history excites you, if you attend an AA meeting that has been around a long time in this Area, you may have a lot of old times in that meeting. We could use your support and we would love to have you join the Archives Committee. I am learning as I go from the outgoing chair. Please, if you are interested in AA history, please reach out to me and we can talk about the Archives Committee responsibilities.

Cindy, Finance Committee Chair. The Finance Committee helps the Area 8 Treasurer create the Area budget. At every finance committee meeting we go through the budget with a fine tooth comb. If you are having trouble understanding the budget, why money is spent on certain things and not on others, then please come to the Finance Committee meeting.

Diana, chair of the <u>San Diego</u>, <u>H&I committee</u>, also known as the San Diego Imperial Area institutional Committee. We take meetings into institutions jails, treatment centers, hospitals where people can't get out to meetings. We coordinate this so that it's done efficiently at places like San Quentin. We're a community of contact on release. We catch people when they leave institutions and connect them with an AA member in the local community, so that person has a contact for AA meetings immediately upon release and has someone to accompany them to the meeting. We do not, as the other committees do, we do not draw from the General Service AA population. H&I draws from the general AA population. We do this by having an orientation. We have two orientations each month. One online on the third Thursday of each month. The other is in person at 5150 Kearney Mesa Road, on the third Sunday of the month at noon. Everyone is welcome to attend. Usually the commitment is you bring a meeting into an institution once a month. It is rewarding work, it is direct 12 Step work, you are being a member of Alcoholics Anonymous instead of just being who you are. I love this work and I would encourage anyone to do this.

Bryan H, Chair, Accessibilities Committee

Two deaf members were on the PRAASA Committee 2022. First time in PRAASA history for 55 years! A total of 1932 members registered. 119 requested Spanish translation. **31 requested ASL translation. 31 deaf members is the most we had ever seen.** It's been a great experience to serve for PRAASA and hoping to see it grow. ASL translated almost all except Round Tables. We selected 4 tables - 2 on Friday & Saturday.

San Diego Spring Round Up 2022, April 14-17. San Diego Spring Round Up Accessibilities Committee collected \$1,200 so far for the ASL budget. The estimated amount for ASL interpretation is \$2,860. 8-10 deaf AA members are planning to register. In the past, we had fundraising events to help with ASL cost so deaf members can enjoy the San Diego Spring Round Up. This isn't happening this year. The last couple of years due to the pandemic the Round Up has been on zoom. We still had meetings ASL interpretation but collection of registration and donations were very low. This year the SDSRUP is in person. Our budget and interpreter list is very low. It'll cost about \$2,860 for the 11 event meetings to be covered. Any donations would be greatly appreciated.
