Presentation of June minutes. Minutes reviewed, accepted and approved

Treasurer report presented by Lynn. Income \$309.70, Expenses \$0.00 Balance: \$3276.17. Natalie made a motion to purchase a ZOOM account for District 6, so we do not continue to use Lynn's personal ZOOM account. Lynn does not mind using her account. Maire will check with Adrian tomorrow on whether District 19 has a district ZOOM account, and if so, how is that account paid for on a monthly bases. Jeffery feels that if other districts have a district account, then we should also do the same as other districts. Annie felt we should wait to find out how the meetings progress, if they become hybridized meetings (ZOOM + in person). 7th Tradition states we are self supporting and our district should establish a ZOOM account for District 19 use. Lynn asked about our large balance and what expenses we might have, because we should make a contribution from the balance to the AA service structure entities. Lynn requested we make the 7th Tradition contribution an agenda item for August meeting. Natalie proposed we make a decision at the meeting this evening to make a contribution. Jeffery proposed setting aside funds to send GSR's to PRAASA in 2021. Lynn would prefer to get some data on PRAASA (location, costs) and which service structures are in more need of contributions than other entities. Old Business: Lauren explained why the AA Membership survey and Group survey is relevant now, even during the pandemic and during our online meeting format. The information gathered is specific to San Diego AA meetings. The survey will be used to determine how we, AA as a whole in San Diego, might better do 12th Step work in San Diego. If so, we will reserve the room for the Area 8 Assembly. Lynn made an announcement that the Grapevine Committee is asking Districts if the Committee can make a presentation at District meetings. Lynn proposed that Grapevine Committee make a presentation to District 19 at our August meeting. District members approved and Lynn will notify Grapevine Committee that they will present at District 19 August meeting.

GSR Reports: John – MASH 4077 meeting on zoom, unlikely we'll meet in person in near future, currently paying rent for room at church (unsure if it is partial or full rent). Meeting is doing well, lots of members in attendance. Annie Thursday Step Study meeting is well attended, unsure if rent is being paid, meeting on zoom. Lynn Friday Night Gratitude meeting is doing well, meeting on zoom, lots of newcomers, finding sponsees at meetings and it is working on zoom. Trying to find an alternate GSR, but no luck. Jeffery North Park Mens meeting is doing well, put an adhoc committee together to address

how the group will begin meeting in person, currently gathering data. Person in charge of adhoc committee put together a comprehensive list of points that will be needed to addressed and solved when meetings go back to rooms. Jeffery offered to share that list with all of us, but will check with group before he sends it. Jeffery extended an invitation to Lauren to attend the Accessibilities Committee meeting in 2 weeks, to make a presentation to members regarding the AA Member / Group survey.
