Cindy reported that the officers of the Finance Committee intend to visit groups, committees, and districts to help them understand the budget process and how to fill out requests for funding of 12 step work. Lynn and Rob, the Area Treasurer and Alt Treasurer, will reach out to the new Area Officers. Lynn reminded us that the Budget Workshop is in July. More information regarding getting assistance is in the Treasurer's report with links. Lynn explained that the Draft proposal for the Budget will be voted on at the September Area Assembly and the results will go out to your districts. There was discussion on whether September was too late for approval of the drafted budget. The treasurer and the Finance Committee will further discuss timelines. The Finance Committee will have a workshop on July 9th.

Post Conference Assembly: What do our Districts & GSRs do now? Cheryl F.

You know, we had our Post Conference Assembly, and now the GSRs are probably asking themselves what they're supposed to do. As DCMs we should remind them that they should be bringing that information back to their group and informing them so that their group conscience is informed and in line with AA as a whole.

Also GSRs should discuss the hourly rate increase for the Spanish interpreters

They should be bringing that to the groups and then returning to the ACM with the group conscience. We also have a motion to address a lack of a quorum which has not been voted on yet..
