10:10 UNFINISHED BUSINESS.

MOTION -Addressing Lack of Quorum: It is moved that language be added to our Area Structure and Guidelines to assist the Area in its proceedings in the event the a quorum is not established.

Current text: (Not applicable) There currently is no text regarding procedure that ought to be taken if a quorum is not achieved. – Review, Discussion & Vote - Adrian O.

This motion creates a procedure only for our Election and Budget Assemblies. Those decisions will have to be ratified at the next assembly. Members have been invited to the mic to share for 1 minute.

<u>Chuck</u>: Chair of the Policy Committee. The Policy committee opposes this motion for the following reasons first: the quorum section is based on Robert's Rules of Order which states that business may not be done without an established quorum.

<u>Rick:</u> In this 21st century it is necessary to be able to - it's mandatory-that we be able to meet and do business without quorum.

Robin: D7- the Downtown Discussion group. We want the quorum to be required.

Andrea, D6: believes that a GSR quorum is necessary.

<u>Christine, GSR D7</u>: Our group is not in favor of this motion. With zoom we are more easily able to achieve quorum. It's a duplication of effort to have to redo at the next mtg

<u>Caroline</u>: If we have an issue with lack of quorum we can alter the way we do things. But to deviate from our current S+G is not the way to proceed. Make the changes at S+G.

Cat: Opposed to the motion She did not repeat all the reasons that others have said.

<u>Charlie: D11 GSR</u>: We should not deviate from using the quorum. But we have the same "old" rules even though our situation has changed. The term Quorum and what it means probably isn't right.

Karen D19: We should not move ahead and change the quorum requirement.

Vicki GSR D11:: Are there other Areas that practice this?

<u>Joey:</u> practical question/concern - If a motion is passed without a quorum and it needs to be ratified by the next assembly, can the discussion be reopened or is it automatically put up for ratification?

Link: Carlsbad: 75% of our members voted in favor of this motion

Nihura: My group agrees with this motion. We cannot stop our business. AA has to go on with business. We have to adapt. Life is change, we have to find ways to keep going.

<u>Caroline:</u> Confirmation at the next assembly sounds "nice" but they weren't in the room when the discussion happened.

Lorena: I don't understand why we'd accept the results of a discussion without a quorum

<u>Jerry S</u>: The election of our current Delegate and our Alt Delegate happened without a quorum. At the following assembly the body confirmed the elections.

Rachel: It's more of a point of clarification. Zoom participants are counted and present at the assembly. So zoom will increase participation.

Chuck: Changes have been made many times over the years to the policies and procedures.

This option is an effort to work around a quorum but it does not change a quorum. We encourage a NO vote.

Adrian will call the vote.

We require a ⅔ majority for this motion to pass. Adrian read the motion again. Karen is preparing the Poll.

Our internet is too weak for the poll. Vote will be taken by raised hands.

Hands on zoom and in the room in favor: 39

In the room: 11 yes, On zoom: 28 yes, Hands on zoom and in the room not in favor: 53

In the room: 26 no On zoom: 27 no

Motion failed. GSRs have no further action to take on this motion.

<u>MOTION: Hourly Rate Increase for Spanish Interpretation -</u> – Review, Discussion and Vote - Adrian O.

<u>Motion</u> to Increase the Hourly Rate from \$35/hr to \$50/hr for Spanish Oral Interpretation atg Area Committee Meetings, Assemblies, Workshops, and related Events. If approved, the new rate is to be retroactive with an effective date of June 1, 2022.

Translators are provided a 1099 and are responsible for the expenses of transportation \$35/hour was established 27 years ago.

Charles, D11 GSR: his group felt strongly that the hourly rate should be increased. Especially because the Spanish community is underserved.

Blaine: Notice that the rate of \$35/hour was established 25 years ago.

Esther: : The work that the interpreters do I greatly appreciate because I totally depend on their services because I don't speak English. We have taken way too long on this conversation. We absolutely need them at every event that we have. The work that they do is paramount, It helps us understand what is going on and what we're talking about. It helps us be able to participate. And I am in favor of this motion.

Teresa: I just wanted to add one thing. My group is entirely in favor of this, They also were saying, Can we give them more? Can we give them more because it's been so many years? Adrian: It's AA, you can do whatever you want. So long as you're willing to deal with the consequences.

Teresa: I would love to do that but I don't have a number. I don't want to negate this motion. I don't want to take that responsibility.

Adrian: OK. Stay active in general service and maybe someday you can bring a motion to increase it again.

The vote will be a poll on zoom, count of hands in person.

The yes vote: 90 The no vote: 6 Motion passed

Her 4year term will be up at the end of this year. She wants to offer her view of AA around the world.

Here are some quotes from Trish's report. The link to her complete report follows these quotations.

"I want to mention here that <u>you have a direct impact on our international work</u>. It is direct . .We have something called the International Literature Fund."

"Every time your group is supporting the General Service Board, and that's the General Service Office through the General Service Board, you're continuing to help carry the message around the world. I really want you to go back to your home groups and say Thank You for me because I get to see the difference that makes."

"When we go to countries like Paraguay, we sometimes get to meet the Bills and Bobs of those countries.

In Paraguay there was actually a wonderful, beautiful nun named Sister Regina. ... She got on her motorcycle, in her white habit, and she drove the backgrounds of Paraguay, stopping at parishes and talking to bishops and anybody she could along the way and is responsible for starting Alcoholics Anonymous there."

MOTION to Increase Check Writing Limit – Review, Clarification, & Vote Adrian O. / Lynn E. There was a friendly motion to increase the check amount to \$300 rather than the \$200 that was in the original motion by the Treasurer and the Treasurer agreed with the friendly motion. This motion was approved to send to groups for a group conscience.

Currently Structure and Guidelines requires two signatures on checks over \$150.00. Due to the rising costs of goods and services nearly all transactions require two signatures. Increasing the cash value of the checks to \$300 and over for two signatures would streamline the Area's reimbursements and save time and money. This motion was approved by the assembly to be taken to the groups for a group conscience.

Area 08 has been a national leader in breaking down barriers so deaf and hard of hearing members can

participate in AA groups and AA general service. This is due to the work of our Accessibilities Standing

Committee, the Sign Language Fund, and a team of ASL interpreters that together create a climate that seeks and values the input and active participation of these members. For background information on the Glide App:
