8:35 Area 08 Structure & Guidelines Review:

Pages 14-15 - VII. Area Assembly Standing Committees and their Composition - Blaine H.

- · Discussion / Examples of Practical Application
 - We have 12 standing committees.
 - San Diego and North County H&I.(Hospitals and Institutions) are exempt from the guidelines.
 They were functioning before the Area guidelines started. They are financially independent.
 They are also unique in CA.

Highlights about the standing committees:

- The Chairs are elected in alternate years. The list of evens and odds can be found in the structure and guidelines.
- A member cannot be a DCM and a Chair at the same time but a DCM can be a member.
- The committee design was for nine members. The members were all GSRs. That is now flexible
- The volunteers for committees must be members of AA and they will have voting privileges on matters of concern to the committee but not at the Assembly since they are not GSRs.
- If a chair is absent from three meetings in a row they can be replaced.

- Our Linguistic Districts have their own service committees.
- Services are lessening at the district level. This is common in other parts of the country.
- There are approx. 220 GSRs in our Area. There are only 25 GSRs on the committees.
- Blaine took a short poll of the Chairs. He got responses from 11 out of 12.
 - How long have you served? How many GSRs and volunteers do you have? How do you meet? What is your average attendance?
 - Chairs serve from 6 months to 42 months, average of 12 24 months; GSR members 2.08; Volunteer members 2.16; average attendance is 4.3 members.
- All the committees meet virtually except the H&I committees.
 Blaine traced the communication from the ACM and Assemblies to the GSRs and expressed the need for improvement.
- In the past there were abbreviated ACM minutes that were sent out. Would that improve communication in the Area for GSRs?
- Why are the GSRs not included on the ACM email list?

Translation of A.A. Literature into ASL

- Bryan H. outgoing Accessibilities Chair "The motion: San Diego Imperial Area 8 will support the proposed agenda item for the 74th GSC of Translating Specified AA Approved Literature

into American Sign Language.

- The Motion that originates from Area 58 is this -
 - To make a plan to begin translating critical AA literature into American Sign Language.
- The Deaf community has Pamphlet 19 GSR representative, in keeping with our primary purpose,
- Currently none of the personal stories in the Big Book have been translated.
 Only the first 164 pages have been translated.
- District and Area business meetings have not been translated.
- A common misconception is that written text is the same as ASL That is not true.
- American Sign Language is a separate language.
- People who were born deaf to hearing parents often suffer from critical language acquisition the first 5 years of their lives. They have language deprivation.
- Reading the Big Book is difficult, reading any AA literature is difficult.
- The Chair of the Accessibility committee in Area 58 has put this motion forward.
- There is no budgetary impact to Area 8.
- Monty is willing to write a letter of support for this motion to be heard at the 2023 GSO conference.
