Lynn pointed out to the GSRs how to use this table for their reports. There are summaries of what was spent and what our contributions were.

90% of our budget was spent and that was GOOD.

She pointed out that expenses minus contributions left us with a balance.

Q: Why does the money sent to GSO vary so much? \$21,500.00 was sent last year and that was a record amount. The amount sent was based on our contributions and what we did not spend.

GSO needed financial support. They had salaries and rent during COVID. We were saving money on rent and transportation. It worked out.

Structure and Guidelines has a formula for what we send to the GSO.

- 1. We take our cash on hand. lets say, \$25,000.00
- 2. We subtracted the Prudent Reserve. \$5,000.00
- 3. We take our Reallocation funds, which were voted on at the Budget Assembly in Nov, '22. The three projects that we invested in came to \$9,100.00.
- 4. Our balance was \$10,888.00

Reallocation Funds: Extra money was reallocated to Area 12 step work and 12 step support. We were able to spend 99.5% of what was reallocated.

\$619.00 was sent to GSO.

MOTION of Support – Bryan H. / Adrian O.

This motion was introduced at the December ACM, 2022, by Bryan H. He was on the agenda under New Business.

We will consider a proposed Agenda Item from Area 58. It reads as follows:

SDIIArea 8 supports the proposed agenda item from Area 58 for the 74th GSC to translate specified A.A. approved literature into American Sign Language.

TIt is proposed that AA World Services and the General Service Office make a plan to begin translating critical AA literature into American Sign Language.

The literature priority list has been identified from a survey of deaf AA members taken 11/02/2022. The priority list includes Big Book personal stories in the upcoming 5th edition, Pamphlet #16, the AA group: Where It All Begins, Pamphlet #19, GSR, General Service Representative, and the AA Service Manual.

Bryan's very informative talk about the importance of this motion, about American Sign Language and about access for deaf alcoholics and deaf group meetings is posted in Google Drive. Bryan H. on Translation of AA Literature to American Sign Language

Motion passed 121 in favor/ 1 opposed. Minority Opinion: He is concerned that these new AA concepts will not be translated accurately in ASL.

- The role of the Council Chair conducts the order of the Central council meetings.
- The Council deals with the fellowship of AA at the local level.
- Their committees handle the fellowship at the local level. The office sells AA literature. The Central Office manager usually brings office issues to the Council.
- Many groups do not have a coordinator. We want to bridge the gap that no alcoholic suffers here in our area. We want to man the phone at the Central Office. We want to spread the word about the resources at the Central Office.
- GSRs deal with AA issues.
- Monty, our Delegate, and Judy, our Central Office manager, are having regular meetings.
- Judy writes a draft of the agenda for the council meeting and the Council Chair collaborates with her to draw up the final agenda.
- On the last Friday of every month one of the Intergroup committees hosts an open house.
 - January 27th Program committee. February 24th will be the Public Information Committee.
- Ques. about the volunteers for the phone answering. Can we come back and do it at the Central Office instead of at home?
 - Ans; YES. The Central Office has a lock box for volunteers who want to come in for phone answering service.
