The Treasurer presented the budget, and made a motion for its approval. The Assembly has the option to make amendments, or accept it as is. A vote of 2/3 is required to pass the budget.

Floor motion from Parker - The GV/LV Chair motions to add \$400.00 to the 2024 annual budget of the Grapevine/La Viña standing committee.

Their budget has been cut by almost 50% and they will need these funds to do their service work.

Questions: What will this \$400 be used for?

The \$400.00 will be spent on Grapevine/La Viña workshops on a Writer's Workshop, an Audio Workshop, and a Grapevine Representative Workshop. In addition we would like to have ASL and Spanish translation at all of our workshops.

#### Motion approved.

Floor motion from Suzanne - To add \$300.00 to the Newsletter budget. The decrease in our budget limits our ability to fulfill our goals. The Treasurer accepts the friendly amendment. The budget for the newsletter would be increased by \$300 to \$1156.00

Motion approved.

Ques from the floor regarding the cost of ASL interpretation and Spanish translation and where those funds come from. Response from the Chair: Committees are responsible for these costs for their workshops and meetings.

The Chair asks: Would you accept this in the form of a friendly amendment to the budget?

Yes in the room and Yes on Zoom. So as a body we have accepted this.

Neither a motion nor a second is required for a friendly amendment.

The Friendly Amendment will add \$700.00 to the 2024 budget.

Discussion followed concerning reasons for the drastic cut in committee budgets and what specifically the needs are for more funding.

Is there anybody who has changed their mind and become opposed to this Friendly Amendment, either here in the room or on zoom? No. If not, we'll just accept this and proceed. Applause.

Rob, Area Treasurer: The 2024 Area Budget was \$56,508.68. Adding the \$700.00 brings it to \$57,208.68. The Budget was approved with the friendly amendment. 94 in favor; 2 opposed. One of the 2 No votes expressed a minority opinion about the amount of money we spend (not sure if I got this right?) No votes were changed.

Alt Chair-Chuck; Every aspect of technology is dealt with in our Area. You don't need to be an expert. We need all kinds of help - audio, communications, software development, and your ideas.

Roxane - appointed Chair of Literature; This committee is very involved in the annual conference in NY. We bring literature around to workshops and conferences.

**Newsletter** - Suzanne, chair. The newsletter reports on the assemblies. We ask Committee chairs, area officers, and many others to write articles so that we may bring information to the groups.

#### 01:10 MOTION - S&G Addition

Section XVIII. Special Services of the Area Assembly - Adrian O.

This motion suggests a new section to Area 8's Structure and Guidelines document. The basic motion is as follows:

# Motion: Add a new section to Structure & Guidelines. <u>Section XVIII.</u>: <u>Special Services of the Area Assembly.</u>

Special Services of the Area Assembly that empowers the Area to contract <u>outside</u> certified Spanish oral interpretation services at a rate of up to \$65 an hour for Area events. This will be performed with the joint coordination of the Area 08 Alternate Chair and an annually appointed Interpretation Liaison from one of the Area's three linguistic Districts. The linguistic Districts will coordinate the appointment of the Interpretation Liaison amongst themselves.

Presentation, Discussion, Vote to Adopt.

**Floor motion** by Lynn E.: Table the motion to 2024 to allow for an ad hoc committee to develop the guidelines for interpreter services. Sufficient inner information to make an informed group conscience and to use a process that honors the structure of the inverted triangle. First: to have an informed group conscience decision considerations such as hourly rate, \$65, contractors may require travel time and other fees; Second, an Ad Hoc committee should be formed to develop these translation guidelines, not just two people (?) This represents 15% of the Area's budget.

Chair called time and asked that the motion be submitted in writing.

There was a second on the motion.

Discussion: Adrian asked that Lynn send a written copy of her motion to the Area secretary. We will now discuss Lynn's motion and then we'll go to a vote as to whether to accept it.

Link: I want to accept Adrian's motion even if it means lots of work down the road. I'd like to see other languages added to it. We may change the hourly rate, but go forward with it as it is today.

Rob, D23: there are only 3 districts that are affected by this motion. Reps from one of these districts have expressed a lot of concerns. I support tabling the motion. It's the first time I've ever heard about it and probably other people who aren't affected by it directly never heard of it.

Charles: Agree with Lynn that the motion be tabled. I think it needs more discussion. You can come up with a more comprehensive solution that can be worked if it's tabled.

Tom, DCM15, one of the three Hispanic districts: We spent months on this motion. We have 27 groups in D15. We were uncomfortable with our interpreters, Bryana, Doris, and \_\_\_?\_\_. We felt they were interpreting what they wanted, not what was said.

Chair calls time - One last person.

Juan, D18, Fallbrook. One of the Hispanic Districts: I brought this motion to my groups.

Chair: Is this related to why or why not we should table it?

Juan: Yes, We can table it.

Chair: Why do you think it's important to table it?

Juan: Because we as a district do not agree with what's going on.

Chair: Right now we have to do something. \$50 is the rate for interpretation. When the groups come back,

We're going to do what we have to do to include everybody. So hopefully it won't cause an issue in the future.

We will go to a vote on whether to table the motion to add to the Structure and Guidelines.

**Are you in favor of tabling this motion?** A simple majority is required to table it. It will be on the agenda for the Orientation Assembly in January.

If you are in favor of tabling it raise your hand.
