## **Delegate's Report (Richard)**

The Delegate is attending meetings with 150 delegates to prepare for the GS Conference. He praised District 9's event and the spirit shown. Planning is underway for the four pre-conference workshops. He complimented the quality and energy of the ACYPAA conference. The Delegate recommended the Plain Language Big Book session on Tuesday. Attendees are limited to 500 people. The Delegate will forward the list of agenda items and those selected for discussion. He will also send the list of items that will be on the GSC agenda and those items that were not included and why. July 12-14 is the *Regional General Forum*.

**2025 budget timeline** (Rob) – Rob presented the timeline. There's a budget prep workshop for the officer and committee chairs, who will receive their draft budget forms soon. Contact the Treasury Team for help preparing your budgets.

Transition the Area from a 501(c)(4) to a 501(c)(3). Shawn T. presented the motion that the Area transition from a 501(c)(4) to a 501(c)(3). There was no written material on the motion so Adrian addressed the difference between a 501(c)(3) and a 501(c)(4).

Shawn made a motion that the Area transition from a 501(c)(4) to a 501(c)(3). It was seconded by Gary.

Rob – Proposed amending the motion to establish an ad hoc committee to look into the process and the cost. It is likely that an attorney that will be needed.

Shawn – Did not accept the amendment.

#### Discussion:

- Forming a 501(c)(3) is a timely process and the filing cost is \$600.
- Further investigation is needed to understand the intersection of 7<sup>th</sup> tradition and taxes
- A nonprofit status could save the Area money for renting event space, software and some IT equipment.
- The Area doesn't preform political activity so it doesn't need to be a 501(c)(4).

The Chair proposed that an ad hoc committee be formed to investigate transitioning to a 501(c)(3) and that it report back to the ACM in March.

The motion was restated that the Area transition from a 501(c)(4) to a 501(c)(3).

**Off-Agenda item** (Shawn) Shawn proposed that the Area begin efforts to bring the General Service Assembly to San Diego.

Discussion:

The Past Delegate and others shared that:

- The previous panel had begun work in 2023 on an application to host the General Service Assembly in San Diego. The roadblock was that San Diego County does not have a venue large enough to meet GSO's requirements a shaded location with seating for 65,000+ people. The Delegate spoke with GSO and learned these are firm requirements.
- It was confirmed that Snapdragon Stadium is not large enough. (40,000+)
- A suggestion was made to co-host with other areas in Southern California.
